**4.1** <u>Judy Evans</u> regarding SVFD Retirement and recognition for 33 years of Volunteer Firefighter Service with the Sasamat Volunteer Fire Department.

## 5.1 PRELIMINARY 2017 BUDGET PRESENTATION AND COUNCIL DELIBERATIONS

<u>Nancy Gomerich, NG Consulting</u>, Presentation to Council regarding the Preliminary 2017 Budget.

Nancy Gomerich presented the Preliminary 2017 Budget. She noted that the budget is part of a 5 year plan, which is based on the Corporate Strategic Plan.

Staff were requested to follow up with TransLink regarding a review of the Major Roads Network (MRN), to determine the feasibility of an opportunity to extend the MRN to Whiskey Cove Lane.

Council asked pertinent questions with regard to the Waste and Recycle Depot (WARD) and the overall proposed Budget. Council concensus was that the increase for WARD be 4% per year over 4 years.

N. Gomerich noted that the Village of Belcarra maintains an overall good financial position.

Mayor Drew thanked Nancy Gomerich for her presentation and noted that the Village is proceeding with a solid plan.
