Mayor Drew called the meeting to order at 7:43 pm.

5. REPORTS

5.1 Nancy Gomerich, NG Consulting, report dated July 24, 2017 regarding 2017 Mid Year Financial Forecast Report

N. Gomerich provided an overall summary of the 2017 Mid Year Financial Forecast Report noting that it has been a busy year for staff.

Residents enquired with regard to the following items:

- Realignment at the end of Main Avenue
 - Superintendent of Public Works will meet with the resident work will continue on this matter.
- Municipal Hall repair
- Roads and drainage
- Proposed new water reservoir
- Trails
 - It was noted that considerable work is taking place on providing pedestrian and bike corridors in the Village

Considerable discussion ensued with regard to bikes accessing the trails and pedestrian/bike safety including guardrails at Avalon Creek. Residents asked pertinent questions.

Nancy Gomerich advised that a copy of the Zoning Advisory Committee (ZAC) Budget will be provided to the Chief Administrative Officer who will advise ZAC members.

That the 2017 Mid Year Financial Forecast Report be received for information; and That the expenditures that do not comply with Policy 195, as detailed in the section of this Report titled "Compliance with Policy 195", be approved.

5.2 <u>Lorna Dysart, Chief Administrative Officer</u>, report dated July 24, 2017 regarding Contract Award – 2017 Drainage Study

L. Dysart outlined the report. Discussion ensued with regard to estimated cost of the contract.

Mayor Drew outlined the report and noted the impact of future development and the effect on traffic in Port Moody, Amnore and Belcarra.

6.2 Councillor Bruce Drake, Project Lead, regarding Enforcement of Fire Prevention Bylaws

Councillor Drake attended a Sasamat Volunteer Fire Department (SVFD) Trustee Meeting. He noted that Fire Prevention Bylaws need to be reviewed. Staff were requested to review Fire Prevention Bylaws with a view to enabling enforcement as the Villages of Anmore and Belcarra need to be able to respond quickly in event of fire.

He advised that considerable work has taken place on a Master Wild Fire Plan in Hinton, Alberta which may be considered for Anmore and Belcarra.

Lorna Dysart was requested to meet with the Anmore Chief Administrative Officer to further discuss working jointly on a long term initiative and synchronizing penalties. Mayor Drew and Councillor Drake will be advised on progress.

Further discussion ensued with regard to inside sprinklers and roof sprinklers.

Discussion ensued with regard to the Dutchman reservoir which holds 50,000 gallons of water. The reservoir has been drained, cleaned, inspected and is ready for use.

A proposed future site for a new reservoir would require approval of a Crown land lease and grant applications.

Chief Sharpe advised the Chief Administrative Officer that due to the fire situation in the Province, there has been a delay on purchase of a portable water pump.
