4. DELEGATIONS AND PRESENTATIONS

4.1 Corporal Neil Roemer, NCO i/c Rural Section – Marine Ops., Provincial Policing, RCMP, Coquitlam Detachment, Introduction to Council

Mayor Drew introduced Corporal Neil Roemer and welcomed him to Belcarra. Corporal Roemer provided background of his career with the RCMP. He noted that the RCMP contingent for the Village will remain at 3 members. Council expressed sympathy for the recent loss of an RCMP member in the community of Abbotsford.

4.2 <u>Nancy Gomerich, NG Consulting</u> regarding Strategic Plan Update & 2018 Budget Discussion

N. Gomerich provided a PowerPoint presentation regarding the 2018 – 2022 Financial Plan Proposals outlining the following:

- Waste & Recycling Fund
- Tax & Fee Summary
- Long Term Capital Plans
 - o Purpose & Goal
 - Work Plan and Status
 - Review of IT, Office Furniture & Equipment, Public Works Equipment,

Considerable discussion ensued and Council asked pertinent questions. Changes to the Financial Plan were made. The Draft Council Report Plan will be updated for the next Council meeting. It was noted that the Tennis Courts would now be referred to as the Multi Use Court.

Council discussed funds transferred in 2006 to the Village from the Community Recreation Association of Belcarra (CRAB) for the Multi Use Court (Tennis Courts). The document provided by CRAB at that time with the transfer of the funds will be reviewed.

Councillor Drake reported on an upcoming addition to the Christmas light display at the Village Entrance. He noted that the addition will be a surprise for the Village Residents when the display appears in December.

9.2 CRAB Pub Night, Saturday, November 17, 2017

Councillor Drake advised that two, 2' x 3' posters will be purchased that are similar to the posters displayed at the Volunteer Appreciation Night. He noted that the posters will have a Belcarra historical theme and will cost approximately \$30.00 each. Councillor Drake suggested that residents reserve tickets as the CRAB Pub Night event is almost sold out.

10. PUBLIC QUESTION PERIOD

<u>Councillor Drake</u> queried with regard to the brine used by the Public Works department on the roads.

Bernie Serné, Superintendent of Public Works, reported that the white lines on the road is the brine solution. He noted that brine works well in advance of a snow storm and that the use of salt is better during or after the snow falls. The brine will stop ice from sticking to the road and helps make the salt work more effectively.

Deborah Struk, 4575 Belcarra Bay Road, queried with regard to:

- The UBCM Community Works Fund (CWF Reserve) and the term that the funds may be kept in reserve
- The 4% rate of water tax for both residents who are connected and not connected.
