  - b. Amend Zoning Bylaw to include STR under the definition of Home-Based Business
  - c. Public Hearing to amend Zoning Bylaw
- Amend Fees & Charges Bylaw and Business License Bylaw to introduce requirement for business license for STR

#### **Recommendation:**

That the Road Ends Land Disposition Policy, Implementation Strategy report dated November 18, 2019 be received for information; and That the Road Ends Land Disposition Policy, Implementation Strategy be forwarded to 2020 Budget Discussions for consideration.

# **Purpose:**

Further to the recommendations of the Revenue Generation Committee (RGC), the following is a proposed implementation strategy for the disposition of land, including road ends, in the Village.

# **Proposed Process:**

Brook Pooni Associates recommend the following steps for moving forward with identifying road ends for disposition by the Village:

- 1. Map road ends
  - a. Identify on a digital map, 7 road ends identified by Revenue Generation Committee (RGC) and confirm the recommendations
  - b. Review water access requirements as applicable under the Community Charter
- 2. Site Surveys
  - a. Determine encroachments, utilities, rights of way, current uses and ownership of each parcel
  - b. Confirm ownership of adjacent parcels (private, Village of Belcarra, Ministry of Infrastructure)
- 3. Conduct property appraisals
- 4. Identify top 3 road ends for disposition
  - a. Criteria to include least encroachments, most developable lots (size, access considerations, etc.), greatest opportunity for revenue generation, consideration for water access and inland properties
- 5. Draft policy for land disposition and obtain legal advice
  - a. Identify regulatory context (*Community Charter*, Village of Belcarra regulations)
  - b. Draft disposition policy (anticipated process includes option for "right of first refusal" to immediate neighbours and notification of neighbours)
  - c. Legal advice

- 6. Present process to Council (in camera)
  - a. Workshop with Council on disposition policy
- 7. Confirm disposition policy (subject to legal advice)

# **Preliminary Legal Input:**

Belcarra's legal counsel have provided a preliminary overview of the basic steps for the road disposition process as set out in Sections 40 and 41 of the *Community Charter*:

- a. Permanent Closure and removal of Highway dedication
- b. Restrictions in relation to highway disposition, closure or alteration.

Additional legal advice may be received when the road ends are being considered for closure and sale.



Re: Consent to Metro Vancouver Regional Parks Service Amendment Bylaw No. 1290

At its November 1, 2019 regular meeting, the Board of Directors of the Metro Vancouver Regional District (Metro Vancouver) gave three readings to *Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019*; directed staff to seek consent of at least 2/3 of the participants to amend the service area to add an extraterritorial area to the regional park function, and following that, forward the Bylaw to the Inspector of Municipalities for approval.

Section 346 of the *Local Government Act* applies to municipal participating area approval and therefore a council may give participating area approval by consenting on behalf of the electors to the adoption of the Bylaw.

I respectfully ask that this matter be included on Council agenda. A sample resolution is set out below for your convenience:

#### RECOMMENDATION

That the MVRD Board:

- a) give first, second and third reading to *Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019*; and
- b) direct staff to seek consent of at least 2/3 of the participants to amend the service area to add an extraterritorial area to the regional park function, and following that, forward the *Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019* to the Inspector of Municipalities for approval.

#### **PURPOSE**

To consider first, second and third reading of the *Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019* that will initiate the inclusion of an extraterritorial area for a portion of Aldergrove Park located in the City of Abbotsford, and to direct staff to seek consent of at least 2/3 of the participants in the regional parks function in relation to the amendment.

#### **BACKGROUND**

The Province of British Columbia is expected to enact a Regulation to specifically authorize Metro Vancouver Regional District to establish and operate the regional parks service outside its boundaries for the portion of Aldergrove Park located in the City of Abbotsford. In anticipation of that Regulation and to facilitate the process in a timely fashion, it is advisable to amend the Regional Parks Service Bylaw to include this extraterritorial area in the defined boundaries of the parks service area.

This report brings forward the proposed bylaw amendment for the Board's consideration.

#### ABBOTSFORD PARTICIPATION IN REGIONAL PARKS

The City of Abbotsford was a long-standing participant in the MVRD Regional Parks function, but after a parks service review, discussions were initiated between Metro Vancouver and the City of Abbotsford that examined the boundaries of the service area and explored consideration of the potential withdrawal of the City of Abbotsford from the MVRD regional parks function. In 2018 the City withdrew from the parks service.

#### Parkland Transfer to Abbotsford

As part of the agreement for the City of Abbotsford to withdraw from the MVRD regional parks service, in May 2018, Metro Vancouver transferred all interests in parkland within the boundaries of the City of Abbotsford to the City of Abbotsford, including the Aldergrove Regional Park. However, since that regional park straddles the border of the Township of Langley and the City of Abbotsford, it was agreed that a single local government to own and operate it. Given the majority of visitors to the Aldergrove Regional Park originate from Metro Vancouver, Metro Vancouver agreed that it was the appropriate jurisdiction to continue to own and operate this park.

# Extraterritorial Area – Aldergrove Regional Park East

This ownership model posed a problem because the portion of Aldergrove Regional Park located in Abbotsford was outside the boundaries of the Metro Vancouver Regional District. Section 333(4) of the *Local Government Act* requires that a service provided outside of regional district boundaries must be identified as a separate participating area for the service "as if it were located in the regional district". Given the unique history and circumstances associated with Aldergrove Regional Park, Metro Vancouver requested a remedy from the Province to authorize an exemption to the statutory requirement.

The Province proposed a Regulation to the *Local Government Act* that would provide the requested exemption, as described below.

#### **MVRD ALDERGROVE REGIONAL PARK REGULATION**

Staff have been advised that the Province is preparing a new Regulation that will make an exception to section 333(4) of the *Local Government Act*, and authorize Metro Vancouver Regional District to establish and operate the portion of Aldergrove Regional Park in Abbotsford as an "extraterritorial area". This extraterritorial area must be included in the defined boundaries of the parks service area, as set out in the Regional Parks Service Bylaw.

#### Land Transfer to Metro Vancouver

In anticipation of the provincial Regulation, the MVRD Board, at its meeting held May 24, 2019, approved the *Abbotsford Disposition of Eastern Portion of Aldergrove Park Land Agreement* between the Metro Vancouver Regional District and the City of Abbotsford for the sale and transfer of the eastern portion of the Aldergrove Regional Park lands within the municipal boundary of Abbotsford back to Metro Vancouver Regional District.

Once the conditions in this agreement are satisfied - a Regulation is in place allowing Metro Vancouver to own and operate the eastern portion of Aldergrove Regional Park without requiring the City of Abbotsford to be a member of the MVRD for regional park purposes - Metro Vancouver will be returned ownership and will continue operation of both the western and eastern portions of the Aldergrove Regional Park, with the eastern portion being an 'extraterritorial area'.

#### **MVRD REGIONAL PARKS AMENDING BYLAW**

The adoption of a bylaw to amend the *Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005* (proposed in this report) is required to bring effect to the aforementioned Regulation. The required amendment to the Regional Parks Service Bylaw is to include the extraterritorial area in the defined boundaries of the parks service area.

In addition, two minor housekeeping amendments are proposed: two section references to the *Local Government Act* that appear in the Amending Bylaw were outdated, and have been updated to reflect the current numbering in the Act.

The Amending Bylaw is before the Board for first, second and third reading. Once third reading is given, the Amending Bylaw will be circulated to all service area participants to obtain their consent to the adoption of the Bylaw. Two-thirds consent of participants is required before the Amending Bylaw can be considered for adoption by the Board. Once consent is obtained, the Amending Bylaw will be forwarded to the Inspector of Municipalities for approval. If approved by the Inspector, the Amending Bylaw will be presented to the Board for consideration of final adoption.

# **ALTERNATIVES**

- 1. That the MVRD Board:
  - a) give first, second and third reading to *Metro Vancouver Regional District Regional Parks*Service Amending Bylaw No. 1290, 2019; and
  - b) direct staff to seek consent of at least 2/3 of the participants to amend the service area to add an extraterritorial area to the regional park function, and following that, forward the *Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019* to the Inspector of Municipalities for approval.
- 2. That the MVRD Board receive for information the report dated October 22, 2019, titled "Regional Parks Service Amendment Bylaw No. 1290", and provide alternate direction.

#### FINANCIAL IMPLICATIONS

If the Board approves alternative one, there will be no additional financial impacts as staff previously anticipated approval of the provincial regulation when preparing the 2020 budget. Under an existing agreement between the MVRD and the City of Abbotsford that has been in place while awaiting Provincial regulatory approval, Metro Vancouver Regional Parks has operated and maintained both the Langley (West) and Abbotsford (East) portions of Aldergrove Regional Park. The operating costs for Aldergrove Park East are included in the 5-year financial plan.

#### **SUMMARY / CONCLUSION**

The Province of British Columbia is expected to enact a Regulation to authorize Metro Vancouver Regional District to operate the regional parks service outside its boundaries for the portion of Aldergrove Park located in the City of Abbotsford, without the City being a participant in the parks service. To bring effect to that Regulation, the *Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005* must be amended to include this extraterritorial area in the defined boundaries of the parks service area. This report brings forward the associated Amending Bylaw for consideration by the Board. Staff recommend Alternative One.

# METRO VANCOUVER REGIONAL DISTRICT BYLAW NO. 1290, 2019

# A Bylaw to Amend Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005

#### WHEREAS:

- A. By Division V of Letters Patent issued January 13, 1972, as amended by further Supplementary Letters Patent, Metro Vancouver Regional District (formerly Greater Vancouver Regional District) was granted the function of operating regional parks (the "Regional Parks Service"), and the participating areas for the Regional Parks Service were deemed to include not only Metro Vancouver Regional District member municipalities, but also member municipalities of the former Vancouver-Fraser Park District;
- B. On July 25, 2005, the Board of Directors of the Metro Vancouver Regional District adopted "Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005", a bylaw to convert the Regional Parks Service and to amend the participating areas;
- C. On April 27, 2018, the Board of Directors of the Metro Vancouver Regional District adopted "Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1260, 2018", a bylaw to amend the participating areas to remove the City of Abbotsford as a municipal participating area for the Regional Parks Service;
- D. The Board of Directors of the Metro Vancouver Regional District has obtained approval from the Province of British Columbia to establish and operate the regional parks service in an extraterritorial area comprising that portion of Aldergrove Regional Park located within the boundaries of the City of Abbotsford;
- E. The Board of Directors of the Metro Vancouver Regional District wishes to amend "Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005";


**NOW THEREFORE** the Board of the Metro Vancouver Regional District enacts as follows:

- 1. The "Greater Vancouver Regional District Regional Parks Service Conversion and Amendment Bylaw No. 1024, 2005" (the "Bylaw") is hereby amended as follows:
  - a) In the preamble of the Bylaw, add new paragraphs G and H respectively, at the end of this section, as follows:
    - "G. On April 27, 2018, the Board of Directors of the Metro Vancouver Regional District adopted "Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1260, 2018", a bylaw to amend the participating areas to remove the City of Abbotsford as a municipal participating area for the Regional Parks Service;

- H. Consent from at least two-thirds of the Service participants to add an extraterritorial area comprising that portion of Aldergrove Regional Park located within the boundaries of the City of Abbotsford was received;"
- b) In section 4 of the Bylaw, titled "Service Area", delete and replace the section in its entirety with the following:
  - "4. The service area for the Service consists of:
    - (a) all that land within the boundaries of the Participating Areas; and
    - (b) all that land in the eastern portion of Aldergrove Regional Park, identified as Extraterritorial Area, as shown on the map in Schedule A, hereto affixed and forming part of the Bylaw."
- c) In section 5 of the Bylaw, titled "Cost Recovery", sub section (b), delete the words "Division 4.3" and replace them with the words "Part 11, Division 3".
- d) In section 6 of the Bylaw, titled "Cost Apportionment," delete the words "section 804(2)(a)" and replace them with "section 380(2)(a)".
- 2. This bylaw may be cited as "Metro Vancouver Regional District Regional Parks Service Amending Bylaw No. 1290, 2019".

#### **Report Purpose:**

This report provides an update on strategic and policy-related health issues discussed at the Tri-Cities Healthier Communities Partnership (TCHCP) meetings from January through June 2019, and identifies potential opportunities for collaboration with municipalities for your consideration.

# Partnership Recommendations for Councils:

During the meeting period of January – June 2019, the TCHCP made the following recommendation and thanks the Councils for their consideration of this recommendation.

# **Completed Partnership Recommendations:**

#### Partnership Recommendation:

THAT councils discuss support the BC Poverty Reduction Coalition's (BCPRC) ABC Plan for an accountable, bold and comprehensive poverty reduction plan for BC, and adopt the BCPRC's proposed municipal resolution

# Background:

The TCHCP is an initiative of key stakeholders within the Tri-Cities communities. Local municipalities, community organizations and Fraser Health partner to facilitate cross-sector action to promote health and wellbeing in each community. The TCHCP aims to: 1) discuss and bring forward strategic health policy issues that are within the purview of a municipality, and 2) facilitate coalition building among community groups that span the social determinants of health. Following the 2018 year-end evaluation, TCHCP leadership and partners continue to work on strengthening partnership functioning and facilitating collaborative action.

#### TC HCP Discussions:

The TCHCP met on January 24<sup>th</sup>, April 4<sup>th</sup>, and May 23<sup>rd</sup> to discuss a variety of community health issues. These meetings focused on food security, family wellbeing and engaging parents/caretakers, social connectedness, and vaping and cannabis. The following summarizes the key discussion points:

- Donna Whitham, Tri-Cities Public Health Dietitian presented on food insecurity, noting that food
  insecurity is a result of poverty. The group discussed opportunities for collective action to
  enhance community food security. Co-chair and city councillor Dr. Amy Lubik provided an
  overview of the BC Poverty Reduction Coalition's ABC Plan and draft municipal resolution that
  local municipalities could adopt to support the ABC Plan.
- Representatives from the Early Childhood Development (ECD) committee, the Ministry of Family
  and Child Development (MCFD), and School District 43 shared strategies on how they engage
  families and caregivers of children around health-related issues. The group discussed challenges
  local families face (i.e. childcare), and opportunities for better information sharing across sectors.
- Dr. Ingrid Tyler provided an overview of tobacco, cannabis, e-cigarettes/vaping products and the
  recent health evidence. Discussion ensued related to the prevalence of vaping in youth and
  opportunities to raise awareness about the health concerns associated with vaping. Restricting
  access to e-cigarette/vaping products was also discussed with a focus on policy options for
  municipalities, including place-based strategies such as licensing and land-use regulations.
- Richelle Foulkes, Community Health Specialist, shared Plan H's updated <u>Social Connectedness</u>
   <u>Action Guide</u>. Discussion ensued around the health and social benefits of supporting
   connectedness at the neighbourhood level.
- Dr. Ingrid Tyler announced that Fraser Health would be participating in the second round of My
   Health My Community Survey (MHMC). MHMC is a population health survey that looks at healthrelated factors at the municipal level. Data collection for the survey will begin early 2020.

#### TC HCP Decisions/Actions/Opportunities:

# Community Food Security

HCP partners expressed interest in establishing a community food security committee. Interested
partners and other community stakeholders met in April and June and are in the process of
setting goals and objectives for a Tri-Cities Food Security committee.

#### Addressing Vaping

 TCHCP partners will continue to explore opportunities for municipalities to restrict access of vaping products, including facilitating conversations with legal representatives from local municipalities and Health Canada. TCHCP partners will also continue to explore opportunities for community-based initiatives to reduce the incidence of vaping, including public education and engagement events.

- Resources from the <u>Vaping Prevention Toolkit</u> developed by BC Lung in partnership with Fraser
  Health and Vancouver Coastal Health were shared with HCP partners. A <u>Micro-funding for</u>
  cannabis and vaping public education opportunity from Health Canada was also shared.
- The TCHCP encourages Councils to work with local and regional partners to explore measures
  within the purview of municipalities to restrict the availability and accessibility of age-restricted
  substances (i.e. cannabis, alcohol, tobacco, and vaping products), including place-based strategies
  such as licensing and land-use regulations.

# My Health My Community

• All five municipalities submitted questions to be included in the MHMC survey. The TCHCP can support communication of the survey and encourage participation across the Tri-Cities.

# **Completed TC HCP Actions:**

Supporting BCPRC's ABC Poverty Reduction Plan

TCHCP made the following recommendation to Councils:
 THAT councils discuss support the BC Poverty Reduction Coalition's (BCPRC) ABC Plan for an accountable, bold and comprehensive poverty reduction plan for BC, and adopt the

BCPRC's proposed municipal resolution

• Port Coquitlam and Port Moody had previously adopted the BCPRC's municipal resolution. The City of Coquitlam sent a letter of support for the ABC Plan to the Province and requested grant funding be provided to municipalities to support addressing poverty at the local level.

#### Alcohol Dialogues

HCP members SHARE, the Fraser Northwest Division of Family Practice and Fraser Health
collaborated to host a community dialogue on drinking alcohol in the community. The event was
held Thursday, May 30<sup>th</sup> at the Executive Plaza Hotel in Coquitlam. Attendees of the event
explored the impacts of drinking alcohol in the Tri-Cities and ways the community can support
safer drinking choices.

#### Financial Implications: None.

#### Conclusion:

The TCHCP continues to work collaboratively to identify health issues in the Tri-Cities and facilitate opportunities for coalition building and collective action. Partners will continue to identify strategic health policy issues within each of the 2019 focus areas, with particular attention to restricting access and reducing the prevalence of e-cigarettes/vaping. Moving forward for 2019, the TCHCP will focus on active transportation, electronic addiction and screen time, and preparing for 2020.

# 4. Vaping and Cannabis

Dr. Ingrid Tyler gave a presentation on vaping, cannabis and tobacco, outlining the health evidence and current legislation for all. Discussion ensued relative to the following:

- Online sales of vaping products can be difficult to regulate
- Port Moody and Port Coquitlam have passed cannabis retail bylaws that oversee density and retail location.

- Smoking bylaws in multi-unit dwellings fall under the responsibility of the strata.
- Schools have Vicarious Liability when it comes to cannabis
- Edibles are currently not legal in Canada. Some US cities have experienced issues related to packaging and labelling of contents in edibles.
- Vape products are widely available and too easily accessible for youth. There are challenges around restricting density of stores that sell vape products.
- Enforcement for vaping has challenges. Fraser Health has Minor Test Shopper Program.
- Provincial legislation around vaping products could be heightened and allow municipalities more jurisdiction over retail of vape products
- Age-restricted substances/products (i.e. alcohol, cannabis, tobacco, vape products) are all treated differently.
- President of Doctors of BC might be able to write an article/blog to raise awareness about vaping.
- Mixing e-liquids in-store can be considered manufacturing.
- For some insurance companies, vaping status is treated the same as tobacco smoking status.
- Community efforts to reduce prevalence of vaping have not been formally evaluated
- Addressing vaping requires a cultural shift; it requires a multi-pronged approach that includes education for parents, children and youth through health facilities, physicians, rec centres, etc.
- Fraser Health partnered with Vancouver Coastal Health and BC Lung to develop vaping resources, including an infographic and fact sheets. Action: Richelle will distribute resources to partners
- Micro-funding is available through Health Canada for education on cannabis and/or vaping and related health effects. Funds available for up to \$1,000 and require a social media post. Action: Richelle will distribute information on funding opportunity
- The issue of vaping will be brought up in a meeting with the Provincial Medical Health Officer and colleagues.

#### 5. Social Connectedness

Richelle shared with the group the updated PlanH's Social Connectedness Local Action Plan. Discussion ensued relative to the following:

- Coquitlam's Youth Strategy looks at social connectedness. It is also a focus of the Port Coquitlam Foundation. The Foundation will be hosting events to address youth social isolation
- Port Coquitlam and Coquitlam have block parties or neighbourhood nights.
   They can be a useful mechanism for connectedness at the neighbourhood level.
- Literature on asset-based community development and social connectedness recognized the role of community connectors/leaders (e.g. the people who are applying for the neighbourhood block party event) and bringing them together to share ideas about connecting neighbours.
- Advertisement of block parties is mostly communicated through social media

The following updates were provided:

Promoting a Healthy Drinking Culture: Alcohol Dialogues:

• The dialogues are planned for Thursday, May 30<sup>th</sup> from 6:00-9:00pm at the Executive Plaza, North Rd. Coquitlam. It will be a fun event to discuss moderation and the culture of drinking in the Tri-Cities.

# Community Overdose Response:

 OD Project Coordinator has been working with FH to conduct a gap analysis/asset map. Part of this project includes doing surveys and interviews. All HCP partners will be sent a link to the survey - please complete! Data collection for the gap analysis/asset map is May 8-June 12<sup>th</sup>.

# Food Security:

- A small group of community partners, including representatives from Fraser Health, Grow Local Tri-Cities (formerly the Farmers Market Society), and SHARE had an initial meeting to discuss community food security. The group expressed interest in forming a Food Security group and plans to meet again in June. A representative from the city of Port Moody will be attending future meetings, as well as representatives from Kwikwetlem First Nation, Douglas College, the TCLIP, and others.
- The city of Port Coquitlam has budgeted for 2 more community gardens.

# My Health My Community

- Fraser Health will be participating in the second round of the My Health My Community Survey (MHMC). MCMH is a local initiative; it is a population health survey that looks at health-related factors and the only source of information at the municipal level.
- Port Moody, Coquitlam and Anmore have all submitted questions that will be included for residents of those municipalities.
- For the second round of MHMC there will 3 sampling strategies: random sample using MSP data; convenience sampling; quota sampling to reach under-represented population groups.
- It would be great if HCP partners can support the uptake of the survey and help communicate it across the Tri-Cities. Port Moody's communications department will be supporting this.

#### Division of Family Practice

#### **NEW BUSINESS**

#### 4. Vaping and Cannabis

Dr. Ingrid Tyler gave a presentation on vaping, cannabis and tobacco, outlining the health evidence and current legislation for all. Discussion ensued relative to the following:

- Online sales of vaping products can be difficult to regulate
- Port Moody and Port Coquitlam have passed cannabis retail bylaws that oversee density and retail location.

- Smoking bylaws in multi-unit dwellings fall under the responsibility of the strata.
- Schools have Vicarious Liability when it comes to cannabis
- Edibles are currently not legal in Canada. Some US cities have experienced issues related to packaging and labelling of contents in edibles.
- Vape products are widely available and too easily accessible for youth. There are challenges around restricting density of stores that sell vape products.
- Enforcement for vaping has challenges. Fraser Health has Minor Test Shopper Program.
- Provincial legislation around vaping products could be heightened and allow municipalities more jurisdiction over retail of vape products
- Age-restricted substances/products (i.e. alcohol, cannabis, tobacco, vape products) are all treated differently.
- President of Doctors of BC might be able to write an article/blog to raise awareness about vaping.
- Mixing e-liquids in-store can be considered manufacturing.
- For some insurance companies, vaping status is treated the same as tobacco smoking status.
- Community efforts to reduce prevalence of vaping have not been formally evaluated
- Addressing vaping requires a cultural shift; it requires a multi-pronged approach that includes education for parents, children and youth through health facilities, physicians, rec centres, etc.
- Fraser Health partnered with Vancouver Coastal Health and BC Lung to develop vaping resources, including an infographic and fact sheets. **Action: Richelle** will distribute resources to partners
- Micro-funding is available through Health Canada for education on cannabis and/or vaping and related health effects. Funds available for up to \$1,000 and require a social media post. Action: Richelle will distribute information on funding opportunity
- The issue of vaping will be brought up in a meeting with the Provincial Medical Health Officer and colleagues.

# 5. Social Connectedness

Richelle shared with the group the updated PlanH's Social Connectedness Local Action Plan. Discussion ensued relative to the following:

- Coquitlam's Youth Strategy looks at social connectedness. It is also a focus of the Port Coquitlam Foundation. The Foundation will be hosting events to address youth social isolation
- Port Coquitlam and Coquitlam have block parties or neighbourhood nights.
   They can be a useful mechanism for connectedness at the neighbourhood level.
- Literature on asset-based community development and social connectedness recognized the role of community connectors/leaders (e.g. the people who are applying for the neighbourhood block party event) and bringing them together to share ideas about connecting neighbours.
- Advertisement of block parties is mostly communicated through social media

# Food Security:

- A small group of community partners, including representatives from Fraser Health, Grow Local Tri-Cities (formerly the Farmers Market Society), and SHARE had an initial meeting to discuss community food security. The group expressed interest in forming a Food Security group and plans to meet again in June. A representative from the city of Port Moody will be attending future meetings, as well as representatives from Kwikwetlem First Nation, Douglas College, the TCLIP, and others.
- The city of Port Coquitlam has budgeted for 2 more community gardens.

# My Health My Community

- Fraser Health will be participating in the second round of the My Health My Community Survey (MHMC). MCMH is a local initiative; it is a population health survey that looks at health-related factors and the only source of information at the municipal level.
- Port Moody, Coquitlam and Anmore have all submitted questions that will be included for residents of those municipalities.
- For the second round of MHMC there will 3 sampling strategies: random sample using MSP data; convenience sampling; quota sampling to reach under-represented population groups.
- It would be great if HCP partners can support the uptake of the survey and help communicate it across the Tri-Cities. Port Moody's communications department will be supporting this.

#### 5. **New Business**

**5.1** Review, reassess and update the Priority list from the Town Hall Meeting of January 19, 2019

Committee members examined the Priority list from the Town Hall Meeting of January 19, 2019 to evaluate cost and risk, associated timelines and the revenue opportunity expected for each item listed. The Priority list will be brought back to the next Committee meeting with the latest ranking information included.

Further discussion ensued with regard to encroachments on Road Ends and strategies the Village may consider including a charge to residents to lease the Road Ends where current encroachments occur.

Discussion ensued with regard to consideration of a Land Transfer Tax. It was determined that this item would be tabled until the next meeting where the Vice Chair will bring an evaluation forward.

- **5.3** Real Estate potential opportunities, brain storming ideas:

Committee members discussed the following:

- The possibility of the acquisition of Crown Land.
- Issues surrounding development close to Metro Park property and the set back requirements.
- The possibility of opening up Midden Road and closing Bedwell Bay Road to develop lots. It was noted that there are water lines under Midden Road that need to be considered.
- L. Dysart will contact the Manager at Metro Parks to determine the set back requirement for development near the park.
- 5.4 Development Cost Charge (DCC) update

Discussion ensued with regard to DCC information available from the Ministry of Community Services of BC. A DCC Best Practises Guide is available on their website. It was noted that there is very little chance that a DCC will apply in the Village, if there are only 2 properties being developed. The possibility of smaller 1/4 acre lot sizes may increase the possible use of DCC's. L. Dysart noted that the new Engineering Consultant may be able to provide assistance regarding DCC's.

Committee members discussed a "late comer" charge for development of new lots where Village water services would be provided.

# Re: Notification Regarding Update to Metro 2040

At its October 4, 2019 regular meeting, the Board of Directors of the Metro Vancouver Regional District (Metro Vancouver) adopted the following resolutions:

#### That the MVRD Board:

- a) approve the updated Metro 2050 Engagement Plan as outlined in the report dated August 15, 2019, titled "Metro 2050 Engagement Plan";
- b) in alignment with the requirements of Subsection 434(3) of the Local Government Act, direct staff to include a Regional Public Hearing as part of the engagement process for Metro 2050;
- c) as per Subsection 433(4) of the Local Government Act, notify affected local governments and the Minister of Municipal Affairs and Housing of the initiated update to Metro 2040; and
- d) direct staff to offer each member jurisdiction the opportunity to co-host a public information meeting on Metro 2050 aligned with respective Council presentations.

Metro Vancouver 2040: Shaping our Future (Metro 2040), the regional growth strategy, is the region's collective vision for how growth will be managed to support the creation of complete, connected and resilient communities; protect important lands; and support the efficient provision of urban infrastructure like transit and utilities. Since its adoption in 2011, Metro 2040 has been a strong and effective tool for managing growth in the region.

Metro Vancouver is updating the regional growth strategy building on its strengths to: extend the time horizon to the year 2050; integrate with *Transport 2050*, TransLink's new Regional Transportation Strategy; consider emerging external forces, such as climate change; and improve upon specific policy areas. Metro Vancouver is committed to working in close collaboration with its member jurisdictions, TransLink, the Province, adjacent regional districts, and other regional agencies throughout the update to *Metro 2040*. The updated strategy, which is targeted for completion in 2022, will be called *Metro 2050*.

By way of this letter, Metro Vancouver is providing formal notification of this update to all affected local governments and agencies per Subsection 433(4) of the *Local Government Act*. A brief summary of the *Metro 2050* development process as well as key elements of planned engagement with member jurisdictions are provided in the report and engagement plan enclosed.

The approval of the *Metro 2050* engagement plan, sets the stage for conversations about the future of growth management in the region between Metro Vancouver, member jurisdictions and other levels of government and regional agencies. There will be many opportunities for you to help shape the region's shared vision and the directions we pursue together to support a growing and livable region.

Metro Vancouver staff would be pleased to present at one of your upcoming Council or Board meetings to provide an overview of the scope of *Metro 2050* and discuss the opportunities for engagement. 

Re: Metro Vancouver Housing 10-Year Plan - Launch and Implementation

As Metro Vancouver's new Chief Administrative Officer, I am pleased to share with you that the Metro Vancouver Board recently approved the Metro Vancouver Housing 10-Year Plan.

As one of the largest non-profit housing agencies in the province, Metro Vancouver Housing provides affordable homes to over 9,400 people (3,400 units) on a rent-geared-to-income or low-end-of-market rental basis. The majority of homes are geared towards families as well as seniors and people with special housing needs.

The 10-Year Plan provides a framework for how Metro Vancouver Housing will provide, preserve, and expand its portfolio of affordable housing in the region.

To support this Plan, Metro Vancouver Housing will invest \$190 million in affordable housing over the next 10 years. This includes \$90 million in renewing and enhancing its existing housing and another \$100 million to develop new affordable housing. This investment will help support Metro Vancouver's target of adding 1,350 new affordable rental units over the next decade. We will also seek to partner with BC Housing and or CMHC to leverage this investment and support even more affordable housing across the region.

The plan emphasises building positive relationships – especially with our member municipalities – as well as with other orders of government, non-profit housing agencies, and the development sector.

There is a real opportunity to provide more affordable housing through existing housing sites and through partnerships, such as working with municipalities to build on public land. To support such partnerships, Metro Vancouver has approved a new \$4 million annual affordable housing requisition as a stable funding source dedicated to building new affordable rental housing on member and regional lands.

I encourage you to review the new 10-Year Plan, and look forward to collaborating with our members and the housing and development sectors to achieve our common goals. The Plan is available at www.metrovancouver.org/housing, and attached to this letter.
