I hope you and your loved ones have been safe and staying healthy.

During these challenging times with COVID-19, my commitment to serve you carries a unique weight because of the unprecedented impact of this pandemic. Thank you for continuing to reach out to our office with your concerns. To help resolve your concerns and issues, I have been staying in close contact with other MPs, Shadow Ministers, and Government services on this issue. I have also been connecting with other local and regional officials and will continue reaching out to community leaders in the Tri-Cities to work together for your safety and wellbeing. We will get through this together as a community.

I recognize during these difficult times, many of you are facing unemployment and uncertainty about how to pay your rent and bills. I have heard your distress on the phone and in your emails. With ongoing social distancing, some of you are feeling the mental health impact of isolation. Whatever challenges you are facing, I understand these are critical times that require extra care.

That is why my office will be offering extended hours of phone service starting April 1st. We will be here to assist you with COVID-19 Emergency Response Benefits and Employment Insurance if you require support.
