Purpose

To obtain the requisite approvals from Council in order to conduct the 2021 By-election as per the Ministerial Order.

Background

In order to conduct a By-election in COVID pandemic, a local government must obtain a Ministerial Order which permits the Village to conduct the By-election. Staff has worked with the Ministry of Municipal Affairs to review the Village of Belcarra Election Procedures Bylaw, No. 515, 2018 (the "Bylaw") and the Local Government Act, RSBC 2015, c. 1 (the "Act") to determine the contents of the Ministerial Order and to address exceptions to the Bylaw requirements in order to hold the By-election on January 23, 2021. The Bylaw already contains a number of provisions to facilitate conducting a By-election in these times, such as using the Provincial list of electors, posting the nomination documents online, and the granting of general authority to the Chief Election Officer to administer the By-election, as needed. However, there were some provisions within the Bylaw which required Ministerial approval to adjust. Those provisions will be discussed below.

The Ministerial Order M429-2020 was granted on November 26, 2020, a copy of which is included as an attachment to this report.

Council must adopt certain resolutions in order to give effect to the contents of the Ministerial Order. Recommendation 1, 2 and 3 are given in order to carry out this action, enabling the Village to conduct the By-election in a manner which adheres to necessary safety procedures.

Recommendation 1 enables all electors in Belcarra to vote by mail ballot. Currently, the Bylaw states that only those electors who are away from the Village on election day or those with health concerns are eligible to vote by mail ballot. By expanding the eligibility for all electors to vote by mail ballot, the Village can ensure that those who wish to vote but have concerns about their safety are not denied the opportunity to vote. The Village can start to accept elector's requests to vote by mail ballot on December 8, 2020 up until January 23, 2021. The election staff will use mail ballot packages for those people who, on election day, wish to vote but do not wish to enter the polling station. Election staff will send out the ballots as soon as the ballots are available to those who have requested them. It will still be the responsibility of the elector to ensure that the mail ballot is received prior to 8 p.m. on January 23, 2021. Notices for the elections will include details about the availability of the mail ballots for all electors.

Recommendation 2 addresses the issue of the number of scrutineers in the voting place. The Bylaw permits 2 scrutineers per candidate per ballot box. As you are aware, the voting will take place in the Village Council Chambers. This number of scrutineers at any one time could be a challenge for COVID occupancy limits. For example, if there are 2 candidates for each position on the ballot and the Village used 2 ballot boxes during the day, there could be up to 16 scrutineers in the voting place at any time during the election. When election staff are included in the occupancy limits, the number of electors within the voting place is greatly diminished. To accommodate as many voters as is prudently safe within the voting place, a reduction in the number of scrutineers during the actual voting is an appropriate compromise. Once the voting has ceased at 8 p.m. on election day, it will not be a problem to permit additional scrutineers to

observe the counting process at that time. As well, election staff will put in place other systems to assist the scrutineers with their tasks for the candidates to offset this change.

Recommendation 3 will enable election staff to minimize the amount of physical contact needed to conduct the election. Normally, electors sign next to their names in the voting book which contains the declaration that they are eligible to vote, as per the Act. This creates a situation in which a great number of people handle the voting book. This type of situation is not ideal in these times. This recommendation will reduce the number of people touching the voting book to election staff only, thereby reducing the potential for transmission within the voting place.

Recommendations 4 and 5, while not incorporated into the Ministerial Order, are still necessary in order to hold the by-election.

Recommendation 4 addresses the issue of the declaration of the election. While the deadline for accepting nominations is December 18 at 4 p.m., those who have submitted their nomination papers are still not officially candidates at that time. A person who has submitted their nomination papers has up 4 p.m. the following week to (a) provide originals of the nomination papers¹ or (b) withdraw from being nominated without the Minister of Municipal Affairs' approval. This means that a nominee has up until 4 pm, December 25, 2020 to withdraw. Once that time period has elapsed, the nominees then become candidates. Once the number of candidates per position is known, the Chief Election Officer may then declare whether the election is by voting or is by acclamation which occurs on the following Monday. However, in this situation, since December 25, Christmas Day, is a day when the Village office is not usually open, the deadline to withdraw is extended to December 28, at 4 p.m.² As such, the official declaration of the candidates cannot occur until the following Monday, which would be December 28, which is the same date for the declaration of the election. Discussions with the Ministry indicate that it is not a problem for the extended date for the withdrawal time period and the date for the declaration of the candidates to be the same day, given the circumstances. However, election staff would prefer to ensure that Council is aware of this fact.

Recommendation 5 addresses the issue of adhering to timelines required for the notices. According to the legislation, the second notice for the advance voting opportunity must be at least 6 days before the advance voting opportunity occurs which is January 13, 2021 in this situation. Because the Tri-City News, the local paper used for the Village official notices, is only published on Thursdays, the Village will only be able to publish the first of the notices³ within specified time frame but not the second

required notice⁴. Community Charter section 94(4) enables Council to establish an alternative means for providing notice if publication is not practicable, so long as the notice is given within the same time period with the same frequency and Council considers it to be a reasonable equivalent to that which would be provided by newspaper publication, if it were practicable. By posting the notice to the Village website, the public notice posting place, and the 6 bus stops⁵, electors will have various opportunities to become informed of the voting dates, times and locations within the mandated time frame.

PROVINCE OF BRITISH COLUMBIA ORDER OF THE MINISTER OF

MUNICIPAL AFFAIRS AND HOUSING

Local Government Act

Ministerial Order No. M429

WHEREAS pursuant to section 167 of the Local Government Act (the "Act"), if the minister considers that special circumstances exist regarding an election, the minister may make any order the minister considers appropriate to achieve the purposes of Part 3 [Electors and Elections] of the Act;

AND WHEREAS on March 11, 2020 the World Health Organization declared the spread of the coronavirus communicable disease ("COVID-19") to be a pandemic;

AND WHEREAS on March 18, 2020 the Minister of Public Safety and Solicitor General declared that a state of emergency exists throughout the whole of the Province of British Columbia;

AND WHEREAS numerous regional districts and municipalities, including the Village of Belcarra, have pending byelections that must take place during COVID-19 response and recovery;

AND WHEREAS the nature of by-elections requires in-person interactions that can increase the transmission risks of COVID-19 and put electors and election officials at increased levels of risk;

AND WHEREAS local governments are required to move forward with by-elections, as soon as practicable, after a vacancy occurs and to serve the democratic interests of their communities;

AND WHEREAS on January 23, 2021 there is to be a by-election to fill one or more vacancies in an elected local government office for the Village of Belcarra in accordance with section 54 of the Act ("the Village of Belcarra by-election");

AND WHEREAS, I believe that the COVID-19 pandemic constitutes a 'special circumstance' for the purposes of s.167 of the Act, and that in order to achieve the purposes of Part 3 [Electors and Elections] of the Act, it is appropriate for me to make the following order;

Authority under which Order is made:

Act and section: Local Government Act, section 167

Other: Local Government Act, sections 54, 110, 120, 125

NOW THEREFORE I HEREBY ORDER, pursuant to section 167 of the Act, that:

- 1) As an exception to section 110 of the Act, and despite paragraph 7 of the "Village of Belcarra Election Procedures Bylaw No. 515, 2018", or an applicable provision of any other bylaw, Council may, for mail ballot voting in the Village of Belcarra by-election, by resolution permit voting by all eligible electors under the Act to be done by mail ballot and, in relation to this, may permit elector registration to be done in conjunction with this voting.
- 2) Despite paragraph 9.1 of the "Village of Belcarra Election Procedures Bylaw No. 515, 2018", or an applicable provision of any other bylaw, Council may, for the Village of Belcarra by-election, by resolution allow only one scrutineer for each candidate to be present at each ballot box in use at a voting place while voting proceedings are being conducted in accordance with section 120 (3) of the Act.
- 3) As an exception to section 125 (1) (b) and (c) of the Act, or any applicable provision of a bylaw, Council may, for the Village of Belcarra by-election, by resolution permit the elector, as directed by the election official responsible, to make an oral declaration that the elector is entitled to vote in the by-election and has not voted before in the same by-election when obtaining a ballot for voting, in which case the election official responsible must make a record that the elector made an oral declaration.

Subject: Sprinklers in New Builds or Major Renovations – Removal of Charges

Recommendation

That the Village of Belcarra Fees and Charges Bylaw No. 517, 2018, Amendment Bylaw No. 576, 2020 be read a first, second, and third time.

Purpose

To amend the Fees and Charges Bylaw to remove fees associated with the inspection of sprinklers in new builds or major renovations.

Background

On June 8, Council passed the following motion:

"That Belcarra ensure that there are no costs assigned by the Village to property owners who install sprinkler systems, which would not be assigned if there were no sprinkler system."

The purpose of this motion is to remove the fees associated with the inspection of sprinklers to encourage homeowners to install the appropriate number of sprinklers according to the *BC Building Code* in either new builds or major renovations. Installation of home sprinkler systems will help enhance the safety of the residents of the property and neighbours and reduce demand on the Sasamat Volunteer Fire Department (SVFD).

The current inspection fee as per the Village of Belcarra Fees and Charges Bylaw No. 517, 2018 is as follows:

- For the first 50 heads, per head \$4.00
- Minimum fee \$68.00
- Each additional head \$4.00

The application fee for Sprinklers to be installed are as follows:

• **Building Permit Application Fee**, includes \$116.00/Construction over \$5,000.00 Plumbing Permit (as per charges for **fire sprinklers** value

Waiving of the inspection fee would save property owners between \$150 to \$350 depending on the size of the home. An inspection will still be required to ensure the sprinkler system has been properly installed. Waiving of the application fee will save the property owners approximately \$116.00 per application.





To All British Columbia Municipalities,

On November 3, 2020 Council passed the attached resolution regarding Flood Risk Mitigation through Green Infrastructure and Natural Assets.

Port Moody City Council is requesting that your Council consider supporting the need for flood risk mitigation and reach out to the Minister of Environment & Climate Change Strategy, the Minister of Municipal Affairs and Housing, the Minister of Agriculture, and the Premier of British Columbia.

In the 2020 UBCM convention, a resolution regarding Flood Risk Mitigation through Green Infrastructure and Natural Assets was slated to be NR16. However, because of a new format and timing constraints, members did not get to vote on this critical environmental protection piece, which was sponsored by the LMLGA executive. As BC faces the challenges of a climate crisis and rebuilding the economy in a more resilient manner, the creation of fish-friendly flood infrastructure is a critical part of a just recovery.

Our current flood protections drastically impact the lives of fish and other species and rarely take into account diffusing polluted water runoff before it ends up in our watersheds. And of course, protecting our fish protects ecosystems as a whole, which in turn protects food webs and keystone species, food security and food sovereignty, and protect fisheries jobs. Nature-based flood-control solutions that provide both flood protection and fish passage are currently not required by regulators or by funding programs for upgrades of existing structures, even though they are well proven to be effective. In fact these win-win solutions provide excellent return on investment and can make our communities even safer from flooding, but are severely underfunded here in BC.

A major flood with our current infrastructure would be catastrophic, upgrading flood infrastructure needs to be a high priority for capital spending. The solution can be one that provides multiple benefits that creates green jobs, helps us adapt to climate change, advances reconciliation and UNDRIP commitments, while also improving recreational and aesthetic values and of course, is economically smart.

Expanding on this last point:

- Existing flood mitigation funding can be leveraged for multiple benefits: studies have found that investment in ecosystem services generates significant economic value and helps communities avoid millions of dollars in future costs.
- o In addition, investing in natural flood control is often cheaper and more efficient than investing in "grey" infrastructure not just in Canada but across the world.
- And finally, data from the United States show that short-term economic benefits –
 jobs and other economic spinoffs from watershed restoration projects are

equivalent to other kinds of public infrastructure works. For example, a \$1M investment in watershed restoration creates between 13 and 22 jobs, and \$2M to \$3.4M in economic activity.

Reducing storm water-related impacts also reduces our communities' exposure to water pollution and flooding-related health hazards and their associated health outcomes, such as waterborne illness, respiratory disease and asthma associated with mold and bacteria, vectorborne disease, stress, injury, and death. Trees, bushes, and greenery have the ability to absorb air pollutants and trap airborne particulates on their leaves, reduce surface and air temperatures. And because it more resilient to climate related impacts it reduces the need to fix grey infrastructure, which saves money for our residents.

Green infrastructure, such as fish-friendly flood infrastructure, also provides a plethora of cobenefits. Such projects increase exposure to the natural environment, reduce exposure to harmful substances and conditions, provide opportunity for recreation and physical activity, promote community identity and a sense of well-being, and provides economic benefits at both the community and household level. These benefits are all known to directly or indirectly benefit public health. The degree to which the environmental, social, economic, and public health benefits of green infrastructure are realized is dependent on a number of factors, including the design, installation, and maintenance of the green infrastructure features.

Evidence is clear that holistic innovative solutions seem more expensive in the short-term, but provincial political will is needed to reap a myriad of co-benefits that far outweigh the upfront costs. Local governments are dedicated to climate solutions; however, with our only means of funding being property taxes, the province needs to come to the table as a funding partner.

We strongly encourage all BC Local Governments to consider the benefits healthier, reconnected ecosystems can have not just in the next year or two, but into the future as we work to build back a better BC. We hope you join us to advocacy to the Provincial Government to support this initiative through grants and funding as part of a just and green economic recovery.

Therefore be it resolved that Union of British Columbia Municipalities request that the federal and provincial governments remove constraints and implement requirements for incorporating green infrastructure and nature-based solutions in flood management to ensure effective flood risk mitigation while maintaining or restoring social, cultural and ecological co-benefits for these systems;

And be it further resolved that Union of British Columbia Municipalities request that the federal and provincial governments promote natural assets as a viable emergency planning solution and provide appropriate funding through the Disaster Mitigation Adaptation Fund,



Investing in Canada Infrastructure Program, Community Emergency Preparedness Fund, Emergency Management BC and other similar emergency planning and mitigation funds.

AND THAT a letter advocating for Flood Risk Mitigation Through Green Infrastructure and Natural Assets as part of a provincial climate resilience strategy, as well as economic green stimulus package, be sent to the Minister of Environment, the Minister of Municipal Affairs and Housing, the Minister of Agriculture, and the Premier of BC;

AND THAT Port Moody write to all other municipalities in BC asking them to write letters of support to the aforementioned ministries.



City Council has been reviewing its memberships in various organizations, taking into consideration the value provided by the organization versus the expense to be a member. At the July 27, 2020 Council meeting, Council had a robust discussion regarding this topic as well as the current format of the annual UBCM Convention.

The resolutions session, in which many municipalities contribute submissions for discussion, are debated at the same time as individual local government Minister meetings are scheduled. Both are important to attend which leaves local government elected officials conflicted with competing priorities since their resolution submission(s) may be discussed at the same time as they are scheduled to meet with a Minister.

Since the 2020 UBCM convention is virtual, this allowed the Ministers meetings to be scheduled from September 14 to 18 with the convention itself taking place from September 21 to 24. It is recognized that the alternate format was developed due to the pandemic although this change may bode well to incorporate as part of the regular convention schedule moving forward. This would allow local government elected officials to participate in the convention as well as attend requested Minister meetings.

It is acknowledged that UBCM is undertaking a review of its existing resolution process to streamline the number and content of submissions which may result in the number of resolutions being reduced.

It would be appreciated if UBCM could provide an update on members' response to the resolution submission process changes and the change in Minister meeting scheduling.

Dear Members of Belcarra Council,

We are writing to thank you for supporting resolutions EB76 and EB77 at the recent meeting of the Union of British Columbia Municipalities (UBCM). Both of these resolutions called on the provincial government to make all prescription contraception in BC available at no cost under the Medical Services Plan.

With your help, these resolutions passed and have already helped push this issue forward. In the recent provincial election, all three major parties pledged to increase access to prescription contraception. We are currently advocating for the inclusion of this important policy in the forthcoming 2021 provincial budget.

In addition to thanking you for your support, we also wanted to offer some additional recommendations for ways that you can step up to support gender equality and promote sexual health in your municipality:

1. Help reduce period poverty by providing free menstrual products in the washrooms of municipal facilities.

In BC, too many people who menstruate have to choose between purchasing menstrual products and purchasing food. When people don't have access to menstrual products they use unsanitary alternatives that jeopardize their health, skip work, miss school, and stay home so that they can't access services and programming that can help them. Lack of access to menstrual products can exacerbate the impacts of poverty in our community, and undermine the health of people who menstruate.

In many of our communities, tampons, pads, and environmentally friendly alternatives are treated like luxury items reserved for people who can afford them. Importantly, we don't do this with other essential products that you would find in a washroom, including toilet paper, hand soap, or paper towels.

With the help of United Way and their Period Promise campaign, some BC municipalities are starting to see the role that they could play in helping to address the issue, with Coquitlam, Victoria, Port Coquitlam, Port Moody, Burnaby, New Westminster, and Vancouver all working towards implementing policies on access to menstrual products in their cities. If you would be interested in hearing about policy options that your municipality could implement, please connect with Neal Adolph of the United Way.

2. Make free condoms available at municipal facilities.

While increased access to prescription contraception is an important step in improving the health and well-being of BC residents, it is not a sexual and reproductive health silver bullet. Prescription contraception can sometimes fail to prevent unwanted pregnancies, and it does not protect against sexually transmitted infections (STIs). While the BC government has promised to make prescription contraception free, that policy has not yet been put into action; even when it is, other barriers may impede some people's access to prescription contraception.

Making internal and external condoms, and small sachets of lubricant, available at discreet locations in public facilities, is a highly cost-effective way to improve sexual and reproductive health in your community. When barrier methods of contraception, like condoms, are combined with prescription contraception like pills or IUDs, they increase the effectiveness of pregnancy-prevention and also protect against STIs.

Access to condoms and lubricant also helps protect the sexual health of people who cannot become pregnant. STIs are a concern for people in the LGBTQ2S+ community as well, and providing safer sex supplies can help reduce stigma and be part of building a municipality that is inclusive and supportive.

Dear Mrs. Struck,

Thank you for your email about conducting a referendum with the election. As I am unaware of the circumstances that led to the resignations prompting the by-election, I am unable to comment on that.

As for the referendum question, we are not in a position to add that question to the ballot at this time, since it is too late to incorporate that into this election. In order to conduct such a referendum at a minimum, we would have had to

- determine and approve the referendum question in advance of the start of this election process;
- advertised for scrutineers for the referendum at the same time as the notice of nominations were placed in the newspaper;
- request additional provisions to be included in the Ministerial Order required in order to conduct any type of election during COVID. We just received that order from the Ministry earlier this week. We know from previous discussions with the Ministry that the Ministry will not amend any Ministerial Order which has been issued.

Even though by-elections to fill vacant positions and referendums can be held at the same time, they are separate processes with different requirements set out within the Local Government Act.
