

#### **VOTING DATES AND LOCATIONS**

GENERAL VOTING will be open to qualified electors of the Village of Belcarra on Saturday, January 23, 2021 between the hours of 8:00 am and 8:00 pm at the Belcarra Municipal Hall located at 4084 Bedwell Bay Road.

AN ADVANCE VOTING opportunity will be available to qualified electors on Wednesday, January 13, 2021 between 8:00 am to 8:00 pm at the Belcarra Municipal Hall located at 4084 Bedwell Bay Road, Belcarra, BC.

**VOTING BY MAIL BALLOT** is also available. Details are provided below.

**If you are not on the list of electors**, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in the Village of Belcarra for at least 30 days immediately preceding the day of registration, and
- not disqualified by the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

To register, resident electors must produce 2 pieces of identification (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**To register, non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the majority of the property owners.

#### MAIL BALLOT VOTING

Pursuant to Ministerial Order M429-2020, all Electors within the Village may vote by mail. The Village is encouraging electors to use this opportunity to help carry out a "safer" by-election during these COVID times.

In order to obtain a mail ballot, you must submit an application form with the information as listed below, by email at elections@belcarra.ca by 4:00 pm on Thursday, January 21, 2021:

- (1) Full name
- (2) Residential address
- (3) Address of the property in relation to which you are voting (for non-resident property electors)
- (4) Method of delivery of your mail ballot package:
  - (a) pick up at the Belcarra Municipal Hall, OR
  - (b) pick up at the Belcarra Municipal Hall by a person authorized by you (identification required), OR
  - (c) regular letter mail through Canada Post to residential address, OR
  - (d) regular letter mail through Canada Post to an alternate address that you provide when requesting the ballot package
- (5) If you are not on the list of electors, to ensure you receive the correct registration application form in your package, you must indicate whether you are going to be registering as a resident or non-resident property elector.


An application form is available on the website, <u>www.belcarra.ca</u>, for your convenience or you may call the office (after Monday, January 4, 2021) at 604-937-4100 to have an application emailed to you. **Please note that once you request a mail ballot, you will not be issued another ballot for this election.** 


To be counted for the election, your completed ballot must be received by the Chief Election Officer no later than 8:00 p.m. on Saturday, January 23, 2021. The completed ballot package may be mailed or dropped off at the Belcarra Municipal Hall. For those of you dropping off your completed ballot, you may leave your completed ballot with an election official at the entrance without entering the building.

## Article as of Jan 4 (1230 PM)

A by election will be occurring shortly in our Village. As a result there will be many opinions - some overly dramatized - about our current and future circumstances.

Those of us still serving on council feel our views might provide a more balanced perspective. None of these comments have been shared in draft or final form with any by election candidate.

Prior to its incorporation in 1979, about 450 people lived in what would become Belcarra. Our future village was a rural and unorganized part of an Electoral Area managed by Metro Vancouver's predecessor, the GVRD. Unfortunately, GVRD was not our best choice for governance since it wanted all private properties expropriated in order to create a major new regional park. One GVRD representative responded to appeals for accommodation by simply observing:

"You can't live in paradise. "

Affected residents agreed it was paradise but felt there was no reason a residential community and regional park could not coexist. The residents won.

Having succeeded in its struggle for municipal status, Belcarra became a member of the GVRD and, despite its size, assumed all the responsibilities of a municipality.

While we must always be conscious that we do not enjoy the significant tax base of neighbouring municipalities (and never will), we have consistently met this challenge, often by novel approaches. It goes without saying, however, that we simply cannot afford all the services that a larger tax base can underwrite.

Our few permanent staff are expected to multitask while we contract for selected services. We engage on an 'as needed' basis for:finances, building inspections, engineering, municipal planning and legal counsel. We spend consulting dollars where salary dollars might be used by larger municipalities. While all expenditures need to be carefully considered, this method has worked well for us for over 40 years.

We maintain our own roads and other infrastructure. We consider, pass and administer our own bylaws. We hold our own public hearings, welcoming resident input.

We periodically review and update our own Official Community Plan to help shape our future. We manage a recycling facility designed to coexist with our abundant wildlife. Less than a decade ago, after many years of discussions, we added a domestic water system available to a majority of our residents.

As well as the above, we ensure fire protection and safety services through support for the Sasamat Volunteer Fire Department (SVFD). SVFD is a Metro Vancouver function which has only two member municipalities, Belcarra and Anmore.

Metro Vancouver appoints one member to the fire department's Board of Trustees. Belcarra and Anmore appoint three trustees each, producing an independent seven member governing body which then elects its own Chair. These trustees are expected to act in the best long term interest of a single fire department serving two communities. Anmore and Belcarra each appoint one representative to Metro Vancouver's Board of Directors and these two individuals formalize Fire Trustee decisions in that setting. SVFD does not 'belong' to either municipality and its Chief is appointed by and reports to the Board of Trustees and not to any politician in either village. This is a unique partnership that has, thanks to dedicated volunteers from both villages, served our communities effectively for over four decades.

While it is true that Belcarra residents don't always agree on everything, it is also true that we have, together, achieved a great deal for a community of only 643 residents. Lions Bay has twice our population (1,318); Anmore over three times (2,210) and Port Moody (a small city by Metro Vancouver standards), over fifty times as many residents (33,531) --- all figures per the 2016 census.

Many of us were attracted to Belcarra because of its forested rural setting; small village feel and character; it's volunteerism, friendships and community events; the spectacular forest and ocean view scapes ... recognized in our motto:

"Between Forest & Sea."

Some feel changes are necessary, while others may feel those changes threaten the very characteristics that attracted them to Belcarra in the first place. Any proposed adjustments must, therefore, always be subject to open discussion and public communication since the likelihood that any one person has all the answers is vanishingly small. We have, nonetheless, found ways to manage a number of changes in a unique, Belcarra manner.

## For example:

Our Waste and Recycling Depot (WARD) is a gated, centralized 'do-it-yourself' drop-off facility. This avoids both the challenges of our topography for curb side pickup and the risk that the wildlife, with whom we share the area, might consider such service an open smorgasbord. (We are all too well aware that when bears become comfortable near humans it seldom ends well.) While not everyone finds WARD ideal it has prevented wildlife problems and offers access six days per week ... something our neighbouring communities do not provide.

Recent efforts to open up public discussion during council meetings is another adaptation unique to Belcarra. It offers residents who attend council meetings the opportunity to ask questions or make comments during council's discussion of a topic prior to any vote taking place. While a public question period also occurs at the end of council meetings, restricting public comments to just that time slot would mean it would only happen after council had already voted.

Any concerned resident might have to wait until the end of the entire meeting to speak. We feel that welcoming questions and comments throughout the meeting is an approach that should continue.

We are in no danger of running out of issues to address. To name just a few: reviewing our Official Community Plan; making an informed cost:benefit assessment of an appropriate fire flow standard for Belcarra; administrative investment in records management and manuals; deciding the future of Midden Road; advancing long term capital planning (including building the necessary reserves); considering recommendations from existing and future committees, to name only a few.

We believe that all such issues can be addressed in a calm, deliberative manner with residents working together.

With regard to issues that are not Belcarra's sole responsibility, such as SVFD's long term plans, we are confident that our three appointees to its Board of Trustees will effectively represent our community. We expect SVFD Trustees to ensure our fire halls meet seismic requirements and appropriate health & safety standards for our volunteers.

We anticipate this will involve a multiyear approach which will see plans refined. Initial commitments towards this work were made at SVFD's Trustees' meeting in August where it was agreed that approximately \$85,000 would be raised annually through Metro Vancouver from each village.

We agree that widespread engagement and communications outreach is important if Council decisions are to be well informed and widely understood. We believe that this should include periodic articles prepared for the Belcarra Barnacle as well as ensuring that easily accessed recordings of all public council meetings continue to be available on the Village's website.

Finally, we are pleased to welcome John Snell now acclaimed as a new councillor and urge everyone to vote for their choice of mayor so that we will once again have a full council.

## Clearing Port Moody and its Streets

Researched By: Ralph Drew, Belcarra, BC, February 2020. Source: The Port Moody Gazette, Saturday, February 9th, 1884.

EDITORIAL: One of the characteristics of Port Moody least agreeable to the stranger and intending settler — indeed, the only natural characteristic which is likely to produce in him anything like a feeling of discouragement — is the immense mass of growing timber, and timber usually of immense size, with which the ground is found to be originally covered.

To a man who has lived in a prairie country, or who is familiar only with the more lightly timbered forests of the Eastern Provinces, these British Columbian woods seem, at the first, quite appalling.

But, after all, they are not nearly so bad as they look; and the plucky axeman and grubber, who attacks a tract of this forest land in good earnest will soon make short work of the timber on it. Still, it must be admitted that the clearing-off, grubbing, and grading of town lots and streets, after the standing timber has already been slashed and burnt-over, is an expensive and troublesome operation.

But especially in-town buildings, there is another view of the matter. In this almost frostless country, nobody ever thinks of excavating in order to lay deeply the foundations of a building, or to provide a frostproof cellar beneath it; so there we dispense with one large outlay found quite indispensable in all building operations, among all of our fellow subjects east of this Province; and a very large item of expanse is thus saved; for these excavations not unfrequently cost as much as the whole superstructure raised above them. It would be well then for distant strangers to be given to understand that for this elsewhere formidable outlay, there is no necessity whatever in any building operations here in Port Moody.

There is another class of outlays ostensibly to be increased in building-up this town, and which are already being incurred, to some extent, which we nevertheless think might be largely ameliorated if not entirely avoided. The private and enterprising individual who have taken to open-up streets adjacent to their own property, have, we see, commenced grubbing and grading such streets, from the soil itself.

Provision is being made for plank sidewalks. This cannot but prove a very expensive, and — we cannot but think — a needlessly expensive process. Not only the sidewalks, but the whole roadway, should be planked. If ever there was a country in the world where planked highways should be the rule, Port Moody is such a place. The soil itself is not good for street making. Where it is not clayey, it is quick-sandy, and it is nearly everywhere springy.

There is scarcely any dry gravel at all. Hence the necessity of planked streets.

Again, timber suitable for street planking abounds here — so much so, indeed, that, at the present time, it is a nuisance. The time will soon come, however, we shall regret not having such supplies to fall back upon. As it is, it is a shame to waste this fine timber; and we should turn it to a useful account whenever we can. Hence, we should use-up large quantities of it planking our streets. These planked streets can be made very much cheaper, very much more expeditiously, and very much better, than ever any can be made by excavating and grading the soil. A little, portable, steam saw-mill, run up to the edge of the woods almost anywhere here about could make planks enough to plank the streets of Port Moody. When these streets wear-out, let our successors - the future citizens of this then large and wealthy city - pave the streets if they feel so disposed. It is certain that no good and satisfactory highways can ever be made through this Port Moody soil.





Above all, trust in the slow work of God. We are quite naturally impatient in everything to reach the end without delay. We should like to skip the intermediate stages. We are impatient of being on the way to something unknown, something new. And yet it is the law of all progress that it is made by passing through some stages of instability—and that it may take a very long time.

And so I think it is with you; your ideas mature gradually—let them grow; let them shape themselves, without undue haste. Don't try to force them on, as though you could be today what time (that is to say, grace and circumstances acting on your own good will) will make of you tomorrow. Only God could say what this new spirit gradually forming within you will be. Give Our Lord the benefit of believing that His hand is leading you, and accept the anxiety of feeling yourself in suspense and incomplete.

### Belcarra Blockwatch


Early January has seen monsoon weather, but snow may still come in the months ahead. Here are a few pointers from the RCMP to help ensure safer winter driving:

- Drive in accordance with the weather. The posted speed limit is the maximum speed under ideal conditions. If it's raining, snowy or icy, drop your speed.
- Make sure all four car tires are in good condition with deep treads (as a minimum).
- Clean all snow/ice from windshields and windows. Do not drive with 'peep hole' vision.
- Give yourself extra time to arrive at your destination.
- Keep extra gloves, winter boots, flashlight in trunk.
- Avoid using overdrive and cruise control on slippery roads.
- Check weather reports frequently.
- Keep your distance from the vehicle ahead. It takes extra time to stop on snowy roads.
- Accelerate and stop slowly to avoid spinning of wheels and sliding.
- Two hands on the wheel at all times and definitely no texting while driving.

It's important to note that AWD is not necessarily better than front or back wheel drive, when driving in snow. Vehicle is heavier and harder to stop, plus:

"While many people think that all-wheel drive is enough to take on dangerous ice and snow, there is almost no difference between AWD equipped vehicles and common front-wheel drive cars when it comes to cornering, braking and handling in winter weather."

Slow down, stay alert, stay safe!

The arrival of George was a surprise. He landed, nonchalantly, one morning on the flat cover of a street light in the crows', (aka Laurel and Hardy's) parking lot, just across from our car.

The Corvids were already there, front and centre, waiting for cheese. They had outdone themselves that day, one of the last soccer game Sundays permitted, finding our Volt among 150 other parked cars. A personal best for the intrepid duo.

Hardy, having mastered Dachshund very early on in our acquaintance, had announced his arrival with a series of barks. Along with Laurel, he was now waiting patiently for brunch to be served from their very own drive thru window.

Above us, George's skinny legs glistened bright pink in December's cold sun. They sported pronounced knobbly knees, comically at odds with his portly frame. His beady eyes peered down at the antics of the Corvids over the rim of a thick yellow beak. Their expression seemed to suggest both undisguised interest and mild distaste.

His under feathers, brilliantly white against the blue of the sky, complemented his pearl-grey wings and back. Winter had added a slight dusky tone to his head and neck and turned the subterminal spot on the end of his bill from red to black.

George is a Glaucous (from the ancient Greek word glaukos, or grey) winged gull. He is one of the largest, bulkiest shorebirds (ranging from two to almost four pounds) in the Pacific Northwest. Many can be seen around Belcarra on the docks and beaches, often mixing in with flocks of other seabird species.

A gull of great resourcefulness, his relatives are found, in steadily increasing numbers, all along the coast from Alaska to Washington. Like many other creatures, they have adapted well to the presence of people, adding refuse from picnic tables, trash cans, land fills and, as it turns out, handouts in parking lots, to their scavenging. In the wild they eat fish, crabs, mussels and clams, small mammals and birds (rabbits/pigeons) as well as eggs. (I once saw one regurgitate a large part of a starfish.)

Juveniles are a mottled brown and will not acquire adult plumage for four years.

Their life span is surprising. Several banded Glaucous winged gulls have been tracked for 21/22 years, and one in BC for 37!

George's gradual insinuation into the parking lot brunch, after that first day, revealed his opportunistic nature. He never arrives first, always leaving the work of finding us to the considerable skills of Laurel and Hardy.

He stays on the fringe- in the wings as it were - and plays the heavy whenever he gets the chance.

With his appearance on the scene, the Corvids changed tactics. 1 box (2 sleeves) of Stone Wheat Thins or White Saltine Crackers.
