



- The Committee will continue to serve until the OCP is adopted (Summer 2022).





## **OCP PLANNING PROCESS**


- December 2021 July 2022 (approximately 8 months)

  - Phase 4: Finalize and Adopt


Urban Systems will be working with staff, the Committee and the Village's consultants throughout the planning process. Village Staff will be involved throughout the process.
