REPORTS 5.

5.1 Ken Bjorgaard, Financial Consultant, report dated June 5, 2023 regarding the 2022 Statement of Financial Information (SOFI)

The Financial Consultant reviewed the report. He advised that the report is a yearly statement of financial information and is filed with the Ministry of Finance and placed on the Village's website. He outlined the required schedules and provided information on each section.

Jim Chisholm, Belcarra resident, queried on the two figures indicated for water and requested clarification on what the funds were for.

The Financial Consultant advised on the funds shown for the water system.

Jim Chisholm, Belcarra resident, asked how much water Belcarra was receiving for the funds paid.

The Public Works & Emergency Preparedness Coordinator indicated that the report on water usage to be presented later on the agenda would provide the answer.

The Mayor called the question on the motion.

5.2 Ken Bjorgaard, Financial Consultant, report dated June 5, 2023 regarding a Finance Standing Committee Terms of Reference.

The Financial Consultant reviewed the report. He advised that the institution of a finance committee was part of Council's strategic plan and outlined the terms of reference for the committee as well as the committee's mandate.

5.3 <u>Stewart Novak, Public Works and Emergency Preparedness Coordinator,</u> report dated June 5, 2023 regarding the 2022 Drinking Water Quality Annual Report

The Public Works and Emergency Preparedness Coordinator provided the figure for the amount of water used in Belcarra in 2022 and in 2021 in response to an earlier question from a resident.

Amended as per the June 19, 2023 Council Meeting

Jim Chisholm, Belcarra resident, asked what the meter readings at the houses indicated for water usage and how much water the Village was dumping.

Questions and discussion with residents attending the meeting continued regarding the amount of water usage by the Village and on the ability of Village staff to track the amount in order to determine how much water the Village was dumping.

Staff provided clarification on the capability to track the amount of water used and the amount of water 'dumped' annually.

<u>Ian Devlin, Belcarra resident,</u> commented positively on the ability of Village staff to maintain the existing water system.

That the 2022 Drinking Water Quality Annual Report be received into the record for information and be forwarded to the Fraser Health Authority for review and comment.

5.4 <u>Stewart Novak, Public Works & Emergency Preparedness Coordinator,</u> report dated June 5, 2023 regarding an Interface Wildfire Development Permit Area Policy and opportunities for public consultation

The Public Works & Emergency Preparedness Coordinator reviewed the report. He advised that the draft policy will be published on the Village's website and an open house will be held to allow for feedback from residents.

That staff be directed to organize an open house with B.A. Blackwell & Associates Ltd. regarding the Village of Belcarra Interface Wildfire Development Permit Area Policy to provide residents with the opportunity for public consultation – comments & questions.

Council discussion ensued on aspects of the draft wildfire development permit area policy.

The Mayor opened the floor to questions from the public.

<u>lan Devlin</u>, <u>Belcarra resident</u>, requested clarification on various green points indicated on the map provided.

A more refined map will be provided by staff.

<u>Jim Chisholm, Belcarra resident,</u> queried whether B.A. Blackwell will make recommendations regarding the national building code.

Staff indicated that recommendations of modifications to buildings will fall within the scope of the BC Building Code and advised that more in-depth questions can be Answered by B.A. Blackwell at the open house.

The Mayor called the question on the motion.

Discussion ensued on the Provincial Government's list, the reaction among various municipalities and the concerns of the effect the government's demands may have on smaller municipalities.

Jim Chisholm, Belcarra resident, expressed concern with persons stepping into flashing light-controlled crosswalk without looking for ongoing traffic.

Klaus Bever, Belcarra resident, requested a review of the motion passed by Council in November 2022 relating to traffic calming.

Further clarification on traffic calming measures was provided by staff.
