

Mayor's Report

This September follows the hottest summer and worst wild fire season on record in British Columbia. The recent heroic efforts by first responders in Kelowna and elsewhere in the province caused fires, seemingly out of control, to be stopped. This work done by them, many who made personal sacrifices and worked endless hours, have captured our hearts. A sincere thank you to all of them.

We look forward to an autumn of cooler temperatures and rain.

Closer to home our SVFD continues to keep us safe. Remember to follow directions provided by Chief Jay Sharpe. Please check your email or the Village website for updates.

Here are the Council highlights since my last update.

Council Meeting, July 10, 2023

Council recognized William Mostrenko's tremendous achievement in receiving the Governor General's Academic Bronze Medal at Heritage Woods Secondary School.

Urban Systems provided a report regarding the Watson Trail entry barrier and provided options for going forward.

Ian Devlin, Belcarra resident, provided a presentation on the Tatlow Reservoir Water system, including details for additional chlorination of the reservoir to allow the minimum set point fill level to be raised. Many residents provided discussion on these matters. Council requested staff to provide additional information at the next meeting.

Paula Richardson (CAO) provided an update on parking and a reminder that permits are required while parking in Belcarra.

Deputy Mayor Ruzycki reported on activities of the Vancouver Port Mayor's Committee meeting.

The Village of Belcarra Financial Plan Bylaw No. 606, 2023, Amendment Bylaw No.613, 2023 was adopted.

Council requested staff to report in September on a resident's concern pertaining to water impact, in conjunction with a report on the Kelly Road construction.

Council Meeting, July 24, 2023

The Village's integrated long-term financial plan and report from the Finance Standing Committee meeting were brought forward.

Additional reports regarding Watson Trail and the Tatlow Reservoir project were received. Further updates were requested for September.

Tree trimming at the end of Marine Ave. was discussed.

A group of Port Moody/Alderside Road residents, made a presentation on upcoming recreational waterfront licensing with the Vancouver Fraser Port Authority.

The new crosswalk beacons at the top of Kelly Road are in place.

A letter in response to correspondence received from the Mayor of the Village of Anmore, is available on the Village website.

The September Council meetings will include items on the Official Community Plan, our water system, interface wildfire development, a strategic plan update, and a Western Canada Marine

Response presentation.

Belcarra Block Watch

Schools will be back in session Tuesday, September 5 and school zone speed limits will once again be in effect: 30km/hr from 8 am to 5pm, Monday to Friday. Prepare for more traffic on the roads in the early morning and afternoon and plan travel times accordingly.

Stay focused behind the wheel and slow down. Keep to posted village speed limits and be extra aware, particularly at drop off and pick up times. Watch for children on crosswalks and our narrow roadsides.

Remember, too, that some children may now be taking regular transit. Therefore approach all stationary buses with increased caution. Shuttles have been known to stop just beyond a crosswalk leaving those who exit

to cross from behind the vehicle, virtually invisible to oncoming traffic. Children should be reminded to wait until the bus is gone and/or they have a clear view of the road in both directions before trying to cross.

Village of Belcarra Posted August 18, 2023 High Fire Danger



Due to the extended periods of dry hot weather, restrictions have been put into effect for tree falling, land clearing, and brush pile clean-up. These conditions are effective immediately.

A fire safety plan needs to be submitted and approved prior to an activity. Fire Safety Plan to include provisions for fire watch and fire suppression capabilities (extinguishers and/or water hoses).




How Fire Smart Are You?



How is Belcarra affected by wildfire?

Most of Belcarra is in the wildland urban interface, where forest meets community. Fire can spread in both directions, from forest to homes and homes to forest. Residents can take actions to significantly reduce the possibility of damage and loss of property, and reduce the risk to public safety.



What is FireSmart™?

FireSmart[™] BC is a program that offers resources and guidance to empower residents to increase the wildfire resiliency of their neighbourhood. Visit



<u>firesmartbc.ca</u> to learn more and access many references, such as the Homeowners Manual and Landscaping Hub, including a fire-resistant plant selection tool.

Did you know?

You can find fire-resistant plants at participating garden centres and nurseries by looking for these tags!





What can you do?

- o Remove debris from your gutters
- o Mow your lawn and keep it under 10cm
- Move combustible materials, such as firewood and propane tanks, at least 10m away from your home
- o Clean under your decks and porches to remove combustible debris, such as leaves and branches
- o Prune trees on your property so that branches are at least 2m above the ground
- o Choose fire-resistant plants, such as mock orange and sumac, for your garden

Lawn watering regulations are in effect May 1 to October 15

Stage 2 - Residential

Lawn watering is PROHIBITED.

Watering trees, shrubs, and flowers is permitted any day from 5:00 am to 9:00 am if using a sprinkler, or any time if hand watering or using drip irrigation. All hoses must have an automatic shut-off device.

Edible plants are exempt from regulations.

Stage 2 - Non-residential

Lawn watering is PROHIBITED.

Watering trees, shrubs, and flowers is permitted any day from 4:00 am to 9:00 am if using a sprinkler, or any time if hand watering or using drip irrigation. All hoses must have an automatic shut-off device.

Edible plants are exempt from regulations.

Stories From The Archives

Big Seiners Invade Upper Burrard Inlet

Researched By: Ralph Drew, Belcarra, BC, August 2023.

Source: Vancouver Sun, Tuesday, July 16th, 1946, page 10.

"Chug-chug of big purse-seine fish boats, one of the most familiar sounds along the British Columbia coast, is being heard today [July 16th, 1946] in upper Burrard Inlet for the first time within the memories of fishing men here."

"The seiners have been granted permission for the first time to cast their nets for anchovies in the inlet above Second Narrows Bridge for two months dating from last midnight. The move has been made to boost the anchovy-canning industry here."

Only in B.C.

"Anchovies, a little larger than sardines, are canned and sold either under the correct name or as 'West Coast Sardines'. B.C. waters are the only place in Canada where the anchovy is caught."

"Small hand-seine boats have been permitted previously to fish anchovies in Burrard Inlet and purse-seiners have been allowed to fish them upcoast. But the supply has not kept pace with the demand."

"Anchovy-canning, a new wartime-created industry in B.C. is being boosted by the world demand for food of all kinds. Two North Vancouver plants, North Shore Packing and Francis Millerd & Co. have been canning these fish."

Deep Cove Ban

"Heretofore, the inlet above Second Narrows Bridge has been primarily a sport fisherman's area with no salmon, herring or other types of seining conducted there. Deep Cove is the section now banned for anchovy-fishing."

"Fisheries Research Board experts will study the new operations, to determine future potentialities of the anchovy in the Inlet."

After Notes:

- 1. In 1947, the 'Deep Cove Ratepayers Association' declared that anchovy fishing had ruined sport fishing at the resort. A petition signed by 1202 persons asked that commercial fishing in the North Arm [Indian Arm] be prohibited.
- 2. A compromise agreement was reached to protect the interests of sport and commercial fishermen alike until the anchovy population was better understood.
- 3. The area subsequently closed to seiners was extended from Deep Cove itself across the North Arm between Cove Cliff and Turtle Island [sic. Hamber Island] to the south and 'The Quarries' [Quarry Rock] and Jug Island to the north.
- 4. The two North Shore canneries, in West Vancouver and North Vancouver, were the only canneries in the British Empire packing anchovies.
- 5. By late Spring in 1948, the schools of anchovies had not returned and the superb spring salmon sport fishery, last experienced in 1946, was gone!

Recreational Dock Licences

Update from the (VFPA) Vancouver Fraser Port Authority

On Thursday, August 24, the VFPA hosted a Zoom call to provide an update on the new dock licence agreements and allow for a question and answer session with the audience.

The following information is copied from the VFPA slides.

The VFPA outlined their role and responsibilities as follows:

"Developing guidelines, design criteria and environmental requirements for existing and new recreational docks. Licencing ~500 recreational docks in Burrard Inlet, Indian Arm, and Port Moody Arm".

The VFPA highlighted two changes made to the licence agreements since their roll out of 2020.

Cancellation: "Going forward all licences will state that unless we are required to comply with any other applicable law, regulation, or legal requirement, we will only be able to terminate for purposes of fulfilling port's mandate under the *Canada Marine Act* and with 15 months' notice". Later in the presentation the VFPA added that they will only terminate a licence:

- "If the licensee is in default under the licence at anytime.
- If legally required (for example, by another governmental decision maker or a court).
- Otherwise, with 15 months' notice, if reasonably required in furtherance of its mandate".

Environmental clean-up responsibility: "Going forward all licences will state that you are only responsible for your own or invited visitor's contamination".

Later in the presentation VFPA noted "Language has been added to the spills clause to clarify that licensees' are only responsible for the remediation of spills and contamination caused by the Licensee or the Licensee's invitees." Further, related to debris clean-up, "The port authority does not remove debris from licensed areas, such as the zones occupied by recreational docks, the beach, or intertidal zone. Licensees are therefore responsible for the removal of debris in proximity to their recreational dock."

Other topics the VFPA addressed included the term length of licences. The VFPA noted "Dock owners can apply to renew their licences after the 10-year term plus the 10-year renewal."

The VFPA noted that they are not seeking to alter any of the current arrangements with respect to boathouses and rail systems.

The VFPA noted that a recreational dock licence is transferable on the sale of ones home. Further, "Sections of the licence specifically set out the process of assigning or transferring your licence".

[note: the VFPA did not speak to group wharves in their presentation].

VFPA intends to update their website, share a link to a summary of "frequently asked questions", and send out updated licence agreements.

Where the birds all sing and the flowers bloom. What have you seen in your garden lately?

If you live on Main Avenue chances are that you have seen a bear in its underwear and, better still, the wonderful sightings of the orcas on their way up Indian Arm. It appears that much of our wildlife are coming back in strength. Judging by the deer eating all my bean leaves and hostas, regular showing of the anchovies in Bedwell Bay, and a report from a boating friend of the large run of pink salmon heading up toward Indian River.

The long period of sunshine has certainly had an effect on the garden with many flowers and fruit appearing before their usual time. Phlox, Japanese anemones and buddleia are all that are left. The second flowering of wisteria and weigelia have finished.

My raspberries have gone into hibernation, but signs of the later varieties are promising. I guess that I will just have to settle for the abundance of blackberries instead. Apples are now starting to fall, and the crop is much larger than most years. Arugula is also prolific this year, so I hope the nearby recovering beans take note and start producing. Not having to cut the grass so often is one plus from the weather but I am sure we will not be surprised to find an alternate task that needs attending.

Doing a bird count each day provides some amusement, watching the Douglas squirrels marshalling their claimed territory and the pecking order of our feathered friends with the raucous Steller's jays trying to take over all the feeding spots only to be ignored by the house finches. A large showing of bandtailed pigeons is getting quite frequent. Early showings this year included brown-headed cowbirds and black-headed grosbeaks, among the 14 or so varieties noted. Of course, watching the antics of the hummers and the rare sighting of the bald eagles makes the pastime enjoyable.


We will be leaving the Village Hall at 9:30 am, and as usual, carpooling. Please let us know if you wish to join us on this trip. All are welcome, both courses are free.


The Book of Form and Emptiness by Ruth Ozeki



Japanese Beetle Control by Nora



You may have seen posters at local garden shops about an invasive "bad bug", the Japanese Beetle. It has now reached Port Coquitlam and Burnaby. The Invasive Species Council of BC increased its surveillance in the Lower Mainland to 6000 traps! Restrictions now apply year-round to the movement of outdoor plants with soil or soil-related matter. This beetle feeds on more than 300 species including fruit trees, grapevines, roses, and many landscape and food plants.

I urge you to read the full ISCBC 23-09 PDF publication on our webpage!

Three main characteristics are: metallic green head, metallic copper-brown wing coverings, and white tufts of hair around the abdomen. Adult beetles feed on leaves, chewing between the veins and leaving a lacy network. Eggs are laid in grassy areas and the larva feed on roots until the cool weather. They overwinter and begin feeding again in spring. Remember to "shake it before you take it" and report any suspicious beetle or evidence of lace-like damage (take photos!) to:

Declining Swallows and InsectsBy Les



As the adage goes, "the changes are acoming", and they are not always good news. For years we used to have barn swallows nesting in our garage and then they disappeared. There were no more flocks migrating north, passing our house in the spring. We also noticed on our road trips that our vehicles were not getting splattered up with bugs to the same extent they used to be. What is the connection? The lack of food, in the form of insects, is why our swallows have gone. Air pollution has an effect on flies, altering how they attract one another and mate. I have to admit, I don't really know about pheromones... Estée Lauder worked for me when I met Kathy!

Pheromones are distinctive to male and females of a species, and in the case of flies, they are being disrupted by the increase of ozone in the air, a result of air pollution. Scientists at the Max Planck Institute for Chemical Ecology in Germany discovered increased ozone levels caused a decrease in pheromones, which caused females to be less attracted to males and led to courtship between male flies. The males started courting each other as they could not distinguish ozonated males from females!

Ozone is thought to affect the patterns of many insects. Such are the irrefutable changes in today's world environment.

Letter to the Editor Fire Halls

Many in the village have no interest in social media so any postings to a Facebook page will remain a mystery. This letter to the editor will hopefully provide clarity regarding the fire hall issue for those who prefer to receive village news via the Barnacle.

2018 (March) An Engineering Assessment was commissioned by SVFD Trustees, Belcarra's ex-mayor Ralph Drew being one them.

2018 (September) Mayor Ralph Drew retired and relinquished trustee status with SVFD. 2018 (October) Belcarra elected Neil Belenkie as Mayor, who then became one of Belcarra's three SVFD trustees.

2019 (April) The Engineers Assessment report was officially presented to trustees, advising that both fire halls were beyond their "best before" date and that replacement should be considered. A proposal for a trustee field trip to inspect Bowen Island's new fire hall was made.

2020 (May 11th) Over a year later, Belcarra's Financial Consultant, Ken Björgaard, presented the Engineer's Report to Belcarra council with the recommendation that funding for fire hall replacement be incorporated into the budget and planning processes of the Village moving forward. This recommendation was defeated by council.

2020 (Fall) Following Neil Belenkie's resignation, Jamie Ross became Belcarra Mayor and assumed the position of SVFD trustee.

2022 (April) SVFD trustees, including two from Belcarra, went on a field trip to Bowen Island, where they met with Bowen's Fire Chief and Deputy Chief.

SVFD Fire Chief Sharpe and Deputy Chief Bolam were also in the party.

2022 (July) SVFD hosted a workshop, outlining and reasoning why there was a need to begin moving ahead on fire hall replacement. A number of trustees, councillors, and public were in attendance at that workshop.

2023 (May) Some ten months later SVFD trustees met. The topic of the fire hall replacement and Anmore's intention to move ahead was made known to all present, including Belcarra's three trustees.

2023 (May 23rd) Ken Björgaard, our Financial Consultant, detailed in a report to council the financial structure of the SVFD, which was verbalized for greater clarification.

2023 (June 5th) Belcarra Mayor reported that trustees attended SVFD trustee meeting on June 1st and that "it was a good meeting". No mention of the fire hall replacement discussions that took place.

2023 (June) Anmore Mayor John McEwen made a courtesy call to Mayor Ross regarding contents of a forthcoming letter regarding next steps for both villages concerning fire hall replacement planning.

2023 (June 23rd a few days later) Both Mayor Ross and CAO received the aforementioned letter. Despite this letter being made public it was placed into "legal" by the CAO and Mayor prior to the council meeting of July 10th.

This prevented and denied any discussion on the issue during the council meeting on the 10th.

2023 (July 24th council meeting) During the public question period, Mayor Ross advised that a return letter to Anmore was being prepared and would be made public when sent.

2023 (July 28th) This return letter, drafted by Belcarra's lawyer and sent from Mayor Ross to Anmore Mayor, advised as follows... "Belcarra is prepared to discuss changes in the governance model and financial rules for the Sasamat Volunteer Fire Department Service with Anmore".

Be that as it may, the fact remains that the trustees have known since April 2019 that the day would come that the issue of replacement of fire halls would become an action item.

That day is fast approaching, and in all probability the issue will surface at the next SVFD Trustee Meeting in early September.

It is likely the design and consultation phases of replacement fire halls will be discussed by the trustees at that time, and in all likelihood with the recommendation to move ahead with the project ASAP.

As the saga unfolds it will be fully reported in the Belcarra Oversight Group page on Facebook.









Letter to the Editor Conflict of Interest By Sherry Chisholm

I am motivated to write this letter because of the many apparent conflicts of interest that the Mayor of our small village appears to have. It seems to me there are too many for our Mayor to make unbiased decisions or even to speak to many issues because of conflict.

Our Village OCP (Official Community Plan) includes some reference to road allowance and docks and therefore the Mayor must recuse himself because of conflict of interest. As the Mayor cannot participate in discussions regarding our future plans for the Village, he is therefore unable to represent the Village on many important matters.

At present the Vancouver Port Authority is sending out a new contract which, in my opinion, is unacceptable and we need a Mayor who can represent us at the Port meetings. Other municipal Mayors are all actively involved in discussions representing their voters at the Port.

Because the Mayor resides beside Tatlow Trail (road allowance) he would be greatly affected if it were sold. He would certainly be required to remove his personal use (encroachment). This, once again, puts him in personal conflict.

When discussing the plan to enhance the Watson Road path, possibly even paving for bikes, once again puts him in personal conflict. It appears to me that he is trying to encourage folks to use Watson Trail only (approximately 100 feet away) and in doing so he leaves Tatlow Trail, by his home, for his quiet personal enjoyment, with no need to remove his encroachment.

Another appearance of conflict is about the sale of Road Allowances (there are approximately 31). If the Village sold only a few upland road allowances we could clear our debt for water and pay our 50% share of the new fire halls that need to be built, and there would be no tax increase added by another long term debt or possibly a per property levy. The Mayor would certainly be personally affected, and once again would need to leave the table.

The Mayor is in conflict on dock discussions, OCP discussions, and any discussions regarding development or even sale of any road allowances because of his encroachment and residential location by Tatlow Road allowance. It seems to me that our Mayor will spend more time off the official table discussion than on.

The council members must openly represent the Villagers on these important Village matters. It seems to me that our Mayor should, for the sake of appearance and his inability to discuss and represent these important matters which greatly concern Villagers, rethink his responsibilities to the Villagers.
