TEMPORARY PARKING PERMIT APPLICATION CONTRACTORS AND DIVERS PARKING

PURPOSE OF CONTRACTORS AND DIVERS TEMPORARY PARKING PERMITS

The Temporary Parking Permit for contractors and divers is issued as part of guidelines adopted by Council to aid staff in managing the parking permit system. It allows the provision of temporary parking for contractors, subcontractors, trades, utility company workers and divers.

Criteria for Temporary Contractors and Divers Parking Permits

(includes contractors, subcontractors, trades, utility company workers and divers)

Guidelines adopted May 9, 2022 in conjunction Traffic and Parking Regulation Bylaw 518, 2018

- Temporary Parking Permits may be issued to contractors, subcontractors, trades, utility company workers and divers with such permits to be linked to a vehicle license plate number and to expire at the end of the respective calendar year (December 31)
- Contractors and/or subcontractors who apply for business licenses may apply for a temporary parking permit in conjunction with a business license application, with such permits to be linked to a vehicle license plate number and to expire at the same time as the business license (December 31)
- Licensed divers are permitted to acquire a temporary parking permit subject to providing their diving license number, along with their vehicle license plate number, and with such permits to expire at the end of the respective calendar year (December 31)
- No vehicle of a resident or a temporary parking pass may remain parked on any street for a continuous period exceeding 72 hours. Residential, Guest and/or Temporary Parking Permits **do not** exempt vehicles from any section of the Traffic Bylaw, with the exception of any section dealing with overtime parking.
