<ul style="list-style-type: none"> to pay the application, the security deposit and the daily usage fee (per the Fees and Charges Bylaw). to pay the costs of actual water usage, where usage costs exceed the daily minimum fee. that the municipality will install a fire hydrant usage assembly and I understand that I do not have access to water supply until the fire hydrant usage assembly is installed. that a disconnection of the fire hydrant usage assembly will occur at approximately 3:00 pm on the expiry date of the permit. to take full responsibility for the fire hydrant usage assembly; and in the event that the fire hydrant usage assembly is damaged, lost or stolen, I will replace it at my own cost. that I am fully responsible for the safety of the public and those working on this project notwithstanding anything in this permit. the Prime Contractor must be skilled in the work assigned and must comply with the WorkSafe / Worker's Compensation Act and Occupational Health Systems Regulations. to indemnify and save harmless the Municipality against any all claims, actions or expenses whatsoever or by whomsoever brought against the Municipality by reason of the Municipality granting to me this permit or by reason of the construction of the above referred works.
