# ANMORE RESIDENTS ASSOCIATION DELEGATION TO COUNCIL MAY 6 2025

Thank you, Mayor and Councilors, for allowing us to come forward today with our delegation. We are here on behalf of our members to discuss our concerns regarding the ongoing proposed land use change public consultation. Many of the residents are confused by the process the village has selected in receiving public input. We believe that much of this is due to the fact that the process seems to be Icona driven. This has created an aura of distrust in our community. Residents feel that the process is being conducted to facilitate Icona's application leaving the impression that this councils' minds, quite frankly, are already made up. Consequently, the resident body are getting increasingly frustrated and feel that their democratic right to having their voices heard is being compromised. We are here today to address what we consider to be a transparency crisis.

#### Statements of Facts:

ø.

The village was formed based on a vision (that of Hal Weinberg and Bob Hunter) known as the ANMORE CONCEPT that the residents wanted to remain semirural and autonomous from the encroaching development of metro Vancouver. In 1987 a referendum was held and 78% of Anmore citizens voted in favor of maintaining RS1 (one acre zoning)

Most of the residents that live in Anmore came here by choice because they love the quieter semi-rural lifestyle which is still close to city amenities. They consider their village to be unique and special.

The Village conducted a consultation process in 2020/21 to help give them better insight of the mood in the community. It was revealed that the residents did not have much appetite for a land use change.

In 2021 there were a number of reasonably sized protests along East Road and Sunnyside against changing the land use from Rural to Urban.

A group calling themselves the Save Anmore Coalition collected over 400 Anmore resident signatures calling for a REFERENDUM on the matter and presented the petition to council on January 11<sup>th</sup> 2022.

Councilor Doug Richardson has sounded the alarm, most recently at that council meeting of April 1 2025, that council needs to "ask the people "what they want.

Icona have been mailing out literature and holding "information" sessions with the support of the Anmore administration' selling their vision leading the residents to believe that this is an assumptive sell on behalf of Icona and is supported by village council.

A large group of residents attended the April 15,2025 council meeting with many of them demanding a referendum which was denied by village council.

ARA recently conducted a poll asking 69 of our members the question. Would you like a referendum. 33 responded "Yes". There was not one "No".

#### What Our Research Tells Us:

"In general, major land use changes do not automatically require referendum. However, in situations where legislation specifies that the "assent of the electors" is needed, a referendum (or assent voting) is the only way to obtain approval. THIS OFTEN OCCURS WHEN LAND USE DECISIONS HAVE A POTENTIAL TO FUNDAMENTALLY ALTER THE STRUCTURE AND GOVERNANCE OF AN AREA."

"For example, if an issue is CONTROVERSIAL, or requires a significant contribution of taxpayers' dollars, or is SIGNIFICANT IN SCALE OR IMPACT ON THE COMMUNITY, local governments may decide that it is more appropriate and cost-effective to proceed directly to assent voting."

#### The Question of Procedural Fairness and Bias:

We wish to speak to the existing ongoing process that has been selected. Mayor and council have already admitted that the process is "proponent driven". We believe that the process goes much further and can be described as proponent (Icona) DOMINATED. It is our opinion that Greg Moore's previous background as a Mayor of Port Coquitlam and Chair of Metro Vancouver give him the insight and skills and relationships to push Icona's request for OCP and Rural to Urban land use changes through. In other words, he has an unfair advantage over ordinary citizens who may oppose him. For this reason, it is imperative that this council pay close attention to the legislation which requires the key principals of procedural fairness such as: 1) Right to be heard, and 2) Impartiality.

#### The Question:

It is our opinion that current OCP/Land Use consultation process lacks transparency mainly because the fundamental question that should be asked appears to be deliberately avoided

and the consultation has proceeded based on the assumption that the Land Use change will be passed. It appears that our council and city officials are conducting this process by putting the cart before the horse and forgot to ask the primary question of the residents: "Do we want it or not?"

#### Advantages To Holding a Referendum:

Anmore is a small community with approximately 2500 residents or 800 households. These demographics lend well to arranging and conducting a vote on the land use proposal in a cost-effective way. Although referendums aren't perfect, they are still the most democratic way of determining the residents' preferred choices.

#### Conclusion:

Icona Properties have been pitching their vision for 5 years and actively involved in driving a one-sided consultation process, using our village facilities and resources to lead that process. As evidence, the April 24ths open house was advertised as an Anmore Village initiative but was staffed by a number of Icona representatives, with Icona's CEO Greg Moore taking center stage. We believe this is a direct afront to the consultation process and shows bias in favor of Icona. We have heard enough from the one stakeholder (Icona). It is our opinion Council have breached the residents trust by giving them too much latitude to promote their vision. We need to hear from the other 2500 residents. Only a referendum can fix this tainted process. We are asking tonight that one of you make a motion to ask the question of the residents of Anmore:

"ARE YOU IN FAVOR OF AN OCP AMENDMENT AND LAND USE CHANGE FROM RURAL TO URBAN?"

"YES or NO"

This one simple move will go a long way in re-establishing our trust in council.

## METRO VANCOUVER REGIONAL DISTRICT BYLAW NO. 1402

#### A bylaw to convert the continued Sasamat Fire Service

#### **WHEREAS:**

- A. By Division X Supplementary Letters Patent approved and ordered August 2, 1979 (the "1979 SLP"), the Metro Vancouver Regional District (formerly the Greater Vancouver Regional District, the "MVRD") was authorized to undertake the function of Fire Regulation with Electoral Areas B and C as participating member municipalities;
- B. Pursuant to Letters Patent approved and ordered August 22, 1979, the municipality of "Village of Belcarra", formerly part of Electoral Area B of the MVRD, was incorporated;
- C. By Division XI Supplementary Letters Patent approved and ordered January 10, 1980 (the "1980 SLP"):
  - (1) the MVRD was authorized to undertake the function of Fire Protection within the Village of Belcarra and that portion of Electoral Area B defined in the 1980 SLP as participating member municipalities; and
  - (2) the 1979 SLP was amended to exclude from the Division X Fire Protection function of the MVRD those parts of Electoral Areas B and C participating in the Division XI Fire Protection function of the MVRD;
- D. Pursuant to Letters Patent approved and ordered November 19, 1987, the municipality of "Village of Anmore", formerly part of Electoral Area B of the MVRD, was incorporated;
- E. By Supplementary Letters Patent approved and ordered March 10, 1989:
  - (1) the 1979 SLP was amended to exclude the Village of Anmore from the Division X Fire Protection function of the MVRD; and
  - (2) the function of Division XI Fire Protection granted by the 1980 SLP was renamed Division XX Fire Protection (the "Service") and revised to, among other things, include only the member municipalities of the Village of Anmore and the Village of Belcarra as participants;
- F. The Service is a continued service and may, by bylaw adopted by the MVRD Board, be converted to a service exercised under the authority of an establishing bylaw pursuant to section 341 of the *Local Government Act*;
- G. The Village of Belcarra and the Village of Anmore, being the only two participating members of the Service, have requested that the Service be converted to one exercised under the authority of an establishing bylaw, as contemplated by this Bylaw; and
- H. Participating area approval of this Bylaw has been obtained in accordance with section 342(2)(c) of the *Local Government Act*.

NOW THEREFORE the Board of the Metro Vancouver Regionals District enacts as follows:

#### Citation

This Bylaw may be cited as the "Metro Vancouver Regional District Sasamat Fire Service 1. Conversion Bylaw No. 1402, 2024".

#### **Conversion of Service**

The Service is hereby converted to and established as a fire suppression, fire prevention and emergency response service exercised under the authority of an establishing bylaw as the "Sasamat Fire Service".

#### **Participating Areas**

The participating areas for the Sasamat Fire Service are the Village of Anmore and the Village of Belcarra (the "Participating Areas").

#### Service Area

The service area for the Sasamat Fire Service is all land within the municipal boundaries of the Participating Areas.

#### **Cost Recovery**

- 5. The annual costs for the Sasamat Fire Service may be recovered by one or more of the following:
  - (a) property value taxes imposed in accordance with Part 11, Division 3 [Requisition and Tax Collection] of the Local Government Act;
  - (b) parcel taxes imposed in accordance with Part 11, Division 3 [Requisition and Tax Collection] of the Local Government Act;
  - (c) fees and charges imposed by bylaw under section 397 [imposition of fees and charges] of the Local Government Act;
  - (d) revenues raised by other means authorized under the Local Government Act or another Act; and
  - (e) revenues received by way of agreement, enterprise, gift, grant or otherwise.

#### **Cost Apportionment**

- 6. The costs of the Sasamat Fire Service after deducting the revenues (if any) received under subsections 5(d) and (e) above and except as set out in section 7 below, shall be apportioned between the Participating Areas by the method established by section 380(2)(a) of the Local Government Act.
- 7. The annual cost of contributions to any capital reserve fund pertaining to the Sasamat Fire Service and the servicing of outstanding debt shall be shared equally (50:50) by the Participating Areas.

#### **Maximum Requisition**

Pursuant to section 339(1)(e) of the Local Government Act, the maximum amount that may be requisitioned for the Sasamat Fire Service is the amount yielded by applying the rate of \$1.25 per each \$1,000 of the net taxable value of land and improvements in the service area.

#### **Board of Trustees**

The Board of the MVRD has by Greater Vancouver Regional District Sasamat Volunteer Fire 9. Department Administration and Regulation Bylaw No. 1204, 2014 established, and shall continue by bylaw provide for, a board of trustees for the administration and operation of the Sasamat Fire Service and associated appointments and voting rules.

#### Services outside Service Area Permitted by Agreement

Notwithstanding section 4 of this Bylaw, the Sasamat Fire Service may provide fire suppression, fire prevention and / or emergency response services outside of the service area where the MVRD has entered into an agreement for such purpose, consistent with section 332 of the Local Government Act.

**Subject:** Information Technology Server Replacement

#### Recommendation

That the Village of Belcarra's 2025 – 2029 capital financial plan be amended by transferring \$12,000.00 from 2026 to 2025 for an information technology server replacement, with funding coming from the General Capital Reserve Fund.

#### **Purpose**

The purpose of this report is to present a proposed budget amendment to replace the Village of Belcarra's information technology (IT) server, which has reached the end of its recommended service life.

#### **Background**

The Village of Belcarra's recently adopted 2025 – 2029 Financial Plan included provision to replace the Village's IT server in 2026 at a cost of \$12,000.00. The Village's information technology service provider, Sea to Sky, has indicated that the server has reached the end of its recommended service life in 2025, and should the Village extend its service life to 2026, an additional warranty cost of approximately \$1,800.00 could be purchased to safeguard against failure. As a result, it is recommended that the server replacement be advanced to 2025.

The Village of Belcarra's entire long-term information technology capital replacement plan will be revisited in the upcoming 2026 budget cycle to ensure that it is consistent with Sea to Sky's latest hardware and software replacement projections, with a condition assessment of all hardware being undertaken before actual replacement.

#### **Financial Implications**

The server replacement is listed in the 2026 financial plan at a cost of \$12,000, and this same amount is being advanced to 2025. The Village of Belcarra's information technology capital asset replacements/upgrades are funded from the Village's General Capital Reserve Fund, which had a balance of \$1,131,617 at the end of 2024.

Subject: Storm Water Network Review and Update

#### Recommendation

That the services of LandInfo Technologies for GIS and asset management planning support be retained; and further

That services be based on hourly rates applicable at the time of invoicing, not to exceed \$15,000 (plus taxes) without prior approval from the Village.

#### **Purpose**

The purpose of this report is to recommend that LandInfo Technologies be retained for GIS and asset management planning support to update the storm water network data.

#### **Background**

The Village of Belcarra (Village) has made significant progress in capturing its infrastructure data. However, notable gaps remain in the storm water collection network. Work is required to refine asset attribute data, complete risk assessments, and identify asset replacements.

The Village applied for \$10,000 from the Provincial Infrastructure Planning Grant Program in December 2024, to support a review and update of the storm water collection network. The Village's share of the project costs in the amount of \$5,000 were planned from the Community Works Reserve Fund.

#### **Discussion**

The Village was awarded \$10,000 from the Infrastructure Planning Grant Program on March 31, 2025, for a Storm Water Collection Network Review and Update project (Attachment 1).

Staff recommend award of the project to LandInfo Technologies. In 2023, LandInfo Technologies developed MyCivitas for the Village, an open-source GIS and asset management reporting platform where infrastructure data is stored, analyzed and reported.

The scope of work includes:

- Review and update of storm water network data, with a focus on improving spatial accuracy and documenting asset condition, material, and diameter of storm network piping.
- Infrastructure data capture, analyzation, and reporting using MyCivitas/QGIS
- Risk assessments, replacement costs, and identification of high priority storm water assets for repair or replacement

#### **Summary**

Staff recommend retaining GIS and asset management planning support from LandInfo Technologies for the Storm Water Collection Network Review and Update project. The information will provide critical updates to storm water infrastructure and asset management data and will also be useful in identifying high priority assets for repair or upgrade.

LandInfo Technologies will provide services on an hourly charge rate basis, not to exceed \$15,000 allotted funding from the Infrastructure Planning Grant and Community Works Reserve Fund.

#### INTRODUCTION

This report is prepared by the Village of Belcarra (Belcarra) under the Water Quality Monitoring and Reporting Plan for the Metro Vancouver (MV) and Member Municipalities. The purpose of the report is to provide Belcarra water consumers and the Medical Health Officer (MHO) with drinking water sampling test results for 2024, and to present background information on Belcarra concerning water supply, treatment, and specific measures being taken to protect and enhance drinking water quality as per requirements under the Drinking Water Protection Act.

#### A. GENERAL DESCRIPTION

Belcarra delivers potable water to its customers via a waterworks distribution system incorporating approximately 11 Km of water mains, one high pressure zone, one low pressure zone, a pumping station, and a water storage reservoir. As of December 31, 2024, the water distribution system provides water to 192 of a possible 270 parcels.

From January 1, 2024, to December 27, 2024, there was 3,127,410 cubic feet (88,558 cubic meters) of water used in Belcarra. This compares to 2023 total water usage of 3,078,115 cu/ft (87,162 cubic meters), indicating an increase of 49,295 cu/ft (1396 cubic meters). The primary use of Belcarra's potable water is residential domestic consumption, however there is one commercial water connection installed in Belcarra Park for public washrooms, irrigation system, and drinking fountains.

Staff continue to monitor water usage for Belcarra Park by tracking total volume and monthly consumption patterns. From December 31, 2023, to December 30 2024 Belcarra Park utilized 2,070 Cu/Meters which totals 205 Cu/Meters less than in 2023.

All Belcarra water is purchased from the Greater Vancouver Water District (GVWD), through the District of North Vancouver (DNV).

#### B. WATER DISTRIBUTION SYSTEM - Village of Belcarra

#### 1. General

The Belcarra water distribution system is comprised of four networks; these are further described as:

- Village of Belcarra Marine Crossing Mains
- Reservoir Supply Main
- Low Pressure Distribution Zone
- High Pressure Distribution Zone on Main Avenue and Bedwell Bay Road

For the purposes of water quality monitoring and reporting in Belcarra, the location where water is drawn from the GVWD transmission system into the DNV system are considered "sources" of the Belcarra potable water system.

A map of the overall water system showing the gravity and pressure zones and water quality sampling site locations is included (See Appendix A).

#### 2. Belcarra Water Quality Testing

Sample tests are performed monthly by Belcarra staff, and twice a month from April to September. Five of the 13 sample stations are tested each month, with all 13 sample stations being tested over a three-month period.

Samples are delivered to the Metro Vancouver laboratory for analysis and reporting. Standard bacteriological parameters analysed by the Metro Vancouver laboratory are Total Coliform, E. coli and Heterotrophic Plate Count (HPC).

The Fraser Health Authority (FHA) may take random samples from; selected sites, or areas where water quality complaints have originated, or where waterworks construction or maintenance activities are underway.

Locations of water quality sampling points in the Belcarra system are based on a guideline provided by the Regional Medical Health Officers as follows:

- i. One sampling point at "source" (supply from GVWD/DNV)
- ii. Twelve sampling points at system dead-ends or near dead-ends

Sampling frequency was completed in accordance with the recommendations provided by the Fraser Health Authority.

A table showing the Schedule for Sampling and Reporting is included (See Appendix C).

#### (a) Physical Parameters

Water temperature and turbidity are measured for all samples and collected for bacteriological testing and are reported in the overall microbiology test results from the Metro Vancouver laboratory. Turbidity is measured in Nephelometric Turbidity Units (NTUs). Health Canada Guidelines for Canadian Drinking Water Quality sets the Aesthetic Objective for water temperature at less than or equal to 15 degrees Celsius and an upper limit of 1 NTU for turbidity. Taste, odour and turbidity are monitored on a complaint basis.

#### (b) Chemical Parameters

In 2024, chemical monitoring in the water distribution system was conducted for the following:

- i. Free chlorine residual The presence of free chlorine: Chlorine is initially added to the water to inactivate the bacteria and some viruses that cause diarrheal disease; and protect the water from recontamination during storage. The presence of free chlorine in drinking water is correlated with the absence of disease-causing organisms and thus is a measure of the potability of water.
- ii. **Haloacetic acids (HAA's)** are a type of chlorination disinfection by-product (CDBP) that are formed when the chlorine used to disinfect drinking water reacts with naturally occurring organic matter (NOM) in water. Haloacetic acids are a relatively new disinfection by-product.
- iii. **Trihalomethanes** (**THM's**) THM's are disinfection by-products. formed when chlorine or bromine interacts with the natural organic materials found in water.
- iv. **pH** Power of Hydrogen. pH is a measurement under the Aesthetic Objective guidelines, with the optimal range of values between 6.5 8.5 pH.
- V. Metals The EPA has set maximum contaminant levels (MCL) for metals including arsenic, barium, cadmium, chromium, lead, copper, mercury, selenium, nickel, thallium, antimony, and beryllium. This means that public water supplies are monitored for these metals regularly

#### 3. Results

Test results for bacteria, temperature, turbidity, and chlorine residual are compiled for each sample site.

#### • Belcarra Bacteria Counts.

A table of results of bacteriological testing of Sample Station Readings of E. coli, HPC, Total Coliform from January to December is attached (See Appendix D).

Metro Vancouver's analysis of HPC confirmed that out of 90 samples submitted, 2 samples exceeded Metro Vancouver's threshold of 500 CFU/ml. All samples were taken from dead end water mains and can be adversely affected by the water age and usage at these dead-end locations. All mains with samples over the threshold were flushed to improve the water quality in those locations.

Metro Vancouver reported that all samples collected in 2024 satisfied the bacteriological requirements of the BC Drinking Water Protection Regulation.

#### • Belcarra Physical Parameters

In 2024, 90 samples were tested for turbidity levels in the Belcarra water distribution system and no samples were greater than 2.8 NTU. Water temperatures ranged from a March low of 5.6° C to an August high of 21.2° C.

#### • Belcarra Chemical Parameters

i. Belcarra water comes from GVWD/DNV where it is received at the Michael Rosen water station. The chlorine residual at that location averages 0.68 mg/l. The water then supplies Tatlow Reservoir and distributed throughout the municipality where other samples are taken at various locations.

90 samples were taken at various end of the run locations. Out of 90 samples taken, none were below the minimum chlorine residual concentration of 0.2 mg/l.

A real time chlorine monitoring station is installed in the Tatlow facility which sends an alarm to all our water service technicians when the system senses a low chlorine reading.

#### ii. Haloacetic Acids (HAA's) – Haloacetic Acids (HAA)

In Belcarra all **8** of the 2024 samples taken were below the MAC of 80 ppb/mL for this parameter (See Appendix E).

#### iii. **Trihalomethanes (THMs)** – Trihalomethanes (THMs)

All **8** of the 2024 samples taken in Belcarra all were below the MAC of 100 ppb/mL for this parameter (See Appendix E).

- i. **pH** All **8** of the samples taken in 2024 were within the Aesthetic Objective guidelines of between **6.5** and **8.5** pH (See Appendix E).
- ii. **Metals** a total of **2** samples for metals, which include testing for copper, lead, and zinc, among other metals were collected in 2024 for Metro Vancouver Metals Sampling Program for Belcarra (See Appendix F). All the metals tested were under the recommended maximum allowable Guideline Limits.

#### 4. Challenges

Keeping chlorine residuals above the 0.20 mg/L is critical for maintaining a healthy and safe water distribution system in our municipality. The combination of cold-water temperatures and ensuring there is no water stagnation in dead end lines help to keep chlorine residuals above 0.20 mg/L.

#### Work Program 2024

- Water sampling ports are installed at the water main ends, and at dead-end branch lines. They are opened to allow additional waterflow as an operational means to move water through the lines thereby helping to maintain the quality of water in these low waterflow areas. However, in extreme cold conditions during winter the testing ports are shut down and drained to prevent freezing.
- A total of 2 new water service connections were processed in 2024.
- 50% of the hydrants were flushed in Belcarra, and in addition to routine flushing Public Works Department monitors the HPC results and will perform additional flushing through the sample ports and fire hydrants when HPC readings are greater than 500 CFU/ml.
- 50% of the hydrants received full tear downs and service. The municipality gets divided into two zones for hydrant servicing; one zone gets a tear down and service, while the second zone receives a hydrant flushing. Each year the services gets switched from the first zone to the second zone.
- Residential and commercial meter boxes were inspected in May and November for condition and water consumption data.
- The Tatlow generator and the fire pump were inspected, tested and serviced as part of the yearly maintenance.
- Deisel fuel tanks were scrubbed.

- Chlorination system detailed design for the Tatlow Reservoir was completed and submitted to Fraser Health for permit review.
- A study report was developed on water deficiencies for fire fighting with recommendations.
- Repainted dutchman reservoir covering the graffiti
- Retrenched around the Base of Tatlow reservoir to improve drainage.
- Replaced a Scada Pack in Tatlow Station. Purchased a back-up Scada Pack as the equipment is becoming obsolete.
- Site inspections were conducted at Strathcona Station on a quarterly basis.

#### INCIDENTS/SIGNIFICANT COMPLAINTS

• One complaint reported on Robson advising the water had a bad taste. Staff tested the water, then flushed and retested. All water samples were within acceptable limits.

#### C. GENERAL WATER ADVISORIES

No water advisories have been issued to date in Belcarra.

#### D. OPERATOR TRAINING/QUALIFICATIONS

Belcarra currently has two water distribution system operators. One EOCP Level 1 Certified Operator, and one EOCP Level 2 Certified Operator, keeping Belcarra in full compliance with provincial regulations. In addition, all public works staff have completed and passed the courses required for level 2 operators' licensing. Staff maintain an ongoing education program to ensure staff stay current and continue to improve their knowledge base.

#### SECURITY MEASURES

Security features at Belcarra include:

- Locked off access to the Tatlow Reservoir with the ladder removed.
- Perimeter fencing around Tatlow Station installed.
- Exterior lighting and fencing for the water receiving building at Midden
- Dual locking mechanisms to enter the Midden and pump station buildings.
- Door alarms at Strathcona chamber & kiosk, and Midden & Tatlow buildings
- Intrusion alarm at the Strathcona chamber sent to the Belcarra Water Operators
- CCTV cameras at Public Works, Midden building, Tatlow reservoir and pump station

#### E. NOTIFICATION AND EMERGENCY RESPONSE PLAN


All water system alarms and emergency phone calls coming from the residents are sent directly to the on call public works staff member who is on duty for the week (24 hr clock). There are three staff members who rotate the duty on a weekly basis.

The on-duty staff member has the ability to view the water control system via SCADA and activate switches from their phone. They will also attend the scene when necessary to control or isolate as needed.

Staff may also utilize a list of contractors that was established for emergency call ins for major line breaks, electrical service, valves, fire pump, and monitoring.


Appendix A

#### Recommendation

That the staff report dated June 9, 2025, titled "Official Community Plan Amendment – Anmore South Update" be received into the record for information.

#### **Purpose**

The purpose of this report is to provide Council with updated information and next steps on the Official Community Plan Amendment Bylaw No. 686-2023 - Anmore South.

#### **Background**

The Village of Belcarra received a letter from the Village of Anmore (Anmore) on February 26, 2025, requesting early comments on the Official Community Plan (OCP) Amendment Bylaw No. 686-2023 for Anmore South. The amendment pertains to an application for proposed development by icona Properties in a designated Special Study Area of Anmore.

On April 1, 2025, the Village of Belcarra (Belcarra) sent a letter to Anmore in response to the request for early comments (Attachment 1). The letter provided initial commentary on the proposal and posed questions related to schools, transportation, construction management, fire safety, civic facilities and parks, and the environment. The letter stated that Belcarra had not completed a thorough review of the information at the time and acknowledged that technical memos were still in progress.

#### **Discussion**

On May 29, 2025, Belcarra received a letter from Anmore regarding updates to the OCP Amendment Bylaw No. 686-2023 (Attachment 2). The letter acknowledges the questions raised during the early consultation in February 2025 and provides information in response.

The letter refers to a May 22, 2025, report to Anmore Council with information on the OCP amending bylaw and draft Neighbourhood Plan as well as other details related to the application. It further notes that additional details of the proposal can be found on the Anmore website.

The letter also provides an update on the process stating that, at the Regular Council meeting on May 27, 2025, Anmore Council directed staff to reduce the number of apartment units and include additional ground-oriented units and return the draft bylaw to Council for consideration of first and second reading.

It states that Anmore Council may schedule a public hearing date at that time for community input. If a public hearing is scheduled, Anmore will provide Belcarra with notice of the public hearing date.

Staff will review all available information related to the proposed development and OCP amendment, with a focus on answering questions raised during the early consultation process. Staff will bring a report back to Council with the updated information.

The Village of Belcarra received the letter dated February 26, 2025, requesting input the proposed Official Community Plan (OCP) Amendment Bylaw No. 686.2023 for Anmore South, which relates to icona Properties Ltd.'s application for the Anmore South lands, a designated Special Study Area in Anmore. In summary, the proposed development includes 2,202 units, opportunities for small commercial businesses, community amenities, and sewer and water connections to service the subject properties. This represents a substantial change on these lands.

At the February 4, 2025 Village of Anmore Council Meeting, passed a motion to initiate the referral process of the OCP Amendment process, including referral to the Village of Belcarra for comment. In response, at the March 10, 2025 Village of Belcarra Council Meeting, Council reviewed the correspondence and passed the following motion:

That the letter from the Village of Anmore be forwarded to the Village planning consultant for review and comment and that staff be directed to provide any other relevant input on OCP Amendment Bylaw No. 686.2023 to the Village of Anmore.

In response to the above noted motion, Pooni Group, the Village's planning consultant, has provided initial planning commentary on the proposal for the Anmore South lands. Staff understand that there are technical memos still in progress, as well as several unresolved questions for the Village of Anmore (noted below), and, therefore, is recommending that a motion be brought forward to ask the Village of Anmore to provide additional time for review to provide a more fulsome response.

#### **PLANNING COMMENTARY**

The following planning commentary is based on a high-level review of the Village of Anmore's Anmore South project webpage, the *Anmore South - Neighbourhood Plan Terms of Reference* (March 2024), and the City of Port Moody's March 26, 2025 letter to Anmore providing high level commentary on the proposed OCP amendment and Neighbourhood Plan. Please note that the Phase 1 and 2 technical reports were not reviewed in detail in the formation of the planning commentary below.

#### **Residential Impacts**

The proposed development includes a substantial increase in residential density, which will have an impact on the surrounding communities, including the Village of Belcarra. Students residing in Belcarra attend the elementary and middle schools located in Anmore.

- Has a study been conducted on how the increased density will impact local school capacity?

#### **Transportation**

The increased traffic associated with the proposed development will impact the existing road network, including Bedwell Bay Road, which is the only road access point for the Village of Belcarra.

- Have the impacts on Bedwell Bay Road been studied and how will they impact Village of Belcarra residents accessing their homes?
- In the summer months, White Pine Beach often results in significant traffic back-ups.
   Has the impact of the proposed development on White Pine Beach traffic been considered?
- Does the proposed development include any plans for public or alternative forms of transportation?
- Has a transportation demand management plan been developed focused on reducing traffic generated by the project?

#### **Construction Management Plan**

Considering the anticipated build out period of 25 years, there will be continuous impacts on the Village of Belcarra, primarily around construction traffic.

- Is there a construction management plan that considers emergency vehicle access during construction?
- Is there a construction management plan that considers Village resident vehicle access during construction?

#### **Fire Safety**

Fire protection is provided by the Sasamat Volunteer Fire Department (SVFD), which is operated as a regional district service by Metro Vancouver and provides fire protection and emergency response services to both Anmore and Belcarra. Both Villages have a fire hall within their jurisdiction. The SVFD Board of Trustees are currently undertaking a service review to address cost apportionment for the fire service.

The Phase 1 Fire Impact Assessment "provides a high-level review of the fundamental legal, regulatory and operational matters that underpin the operation of fire services. It provides baseline information on Anmore South and the Sasamat Volunteer Fire Department (SVFD), representing the first phase of a detailed study for addressing impacts of community growth." Belcarra requires consultation as further studies are developed to address the implications to the SVFD with the increased population density anticipated.

#### **Civic Facilities and Parks**

The only civic facility the Village of Belcarra currently has is in the form of its Municipal Hall - residents mostly travel to Port Moody or Coquitlam for libraries, community centres, pools, and arenas. Belcarra is fortunate enough to have access to beaches and parks, with Sasamat Lake

and White Pine Beach being the most frequently visited by residents and visitors from further afield.

- What types of community facilities are contemplated as part of the Neighbourhood Plan?
   Will they be designed to serve both Anmore residents and visitors from other municipalities?
- An increase in residents will put strain on existing park space in the area. What types of on-site green and open spaces are proposed to serve the future residents of Anmore South?

#### **Environment**

The proposed greenfield development will require the removal of a significant number of trees and will also increase the impervious area and potential for stormwater runoff. There may also be impacts to environmentally sensitive areas and ecosystems that may have far reaching effects.

- What is the stormwater management plan both during construction and after development is complete?
- Are there environmentally sensitive areas or ecosystems within the study area? If so, how will they be addressed to ensure minimal negative impacts?
- Tree canopies have environmental and health benefits, including providing environments for birds and wildlife, and helping make communities more resilient against extreme heat. What is the tree plan for the project?

Based on the background and planning commentary provided above, and considering that the Village requires responses to the questions and comments raised, at the regular meeting of Belcarra Council, the following motion was passed

That the letter dated April 1, 2025 to the Village of Anmore regarding the Anmore South Lands OCP Amendment Application and Neighbourhood Plan be sent; and further

That staff's request in the letter for an additional 60 days to respond after supporting technical memos are made available and questions in the letter dated April 1, 2025, have been addressed by the Village of Anmore be approved.

We appreciate the opportunity to comment on the proposed Anmore South Lands Official Community Plan amendment. We look forward to your response to the comments and questions raised in this letter, as well as the Village's request for additional time to provide a more complete response once those comments are addressed.

As indicated to you in February 2025 as part of the Section 475 referral process, the property owner, icona Properties Ltd., is proposing a vision for development for the subject property that would include a broader mix of housing beyond single-family detached homes, as well as introducing commercial land use in the OCP.

A key requirement of this application is an amendment to Anmore's OCP and the development of a Neighbourhood Plan. The proposed vision for the property includes the 2,202 total homes with unit mix composed of 20 single-family homes, 120 duplexes, 760 townhomes and 1,302 apartments. Opportunity exists for adjustments to the unit types; however, the maximum number of units is 2202. Additionally, the property includes:

- a 20,000 sq. ft. civic community centre on a 0.49 ha (1.21 ac) site;
- two civic development reserve sites totaling 0.48 ha (1.19 ac) to provide the opportunity for additional future civic uses;
- two mixed-use sites totaling 1.50 ha (3.70 ac) with the opportunity for ground floor commercial use, anticipating 50,900 61,800 sq ft of commercial floor space, and 10,000 sq. ft of professional office space;
- conservation and recreation lands totaling 21.35 ha (52.76 ac) of retained existing forest, representing 35% of the plan area;
- neighbourhood parks totaling 4.34 ha (10.72 ac) of public open space distributed within a 5 minute walk of each home;
- dedicated off-street trails, multi-use paths and greenways totaling approximately 5 km;
- a pedestrian and cycling network including greenways and community pathways; and
- new municipal infrastructure with respect to water and sanitary services.

Given that the Anmore South lands are designated as a Special Study Area in both the OCP and Metro Vancouver's Regional Growth Strategy (Metro 2050), the following applications are necessary to facilitate a future rezoning of the subject properties:

- amendments to the OCP, which includes a new Neighbourhood Plan for the Anmore South neighbourhood;
- amendments to the OCP to ensure consistency between the Neighbourhood Plan and general statements and policies;
- amendments to the Village's Regional Context Statement;
- with respect to Metro 2050. an application to Metro Vancouver to amend the regional Urban Containment Boundary to include the Anmore South and to permit future connection to regional sanitary sewer and water services; and
- with respect to Metro 2050, an application to Metro Vancouver to change the land use designation from Rural to General Urban and from Rural to Conservation and Recreation as specified on the Neighbourhood Plan land use map.

At the Regular Council meeting on May 27, 2025, Council directed staff to reduce the number of apartment units, include additional ground-oriented units and return the draft bylaw to Council for consideration of first and second reading once completed. Council may consider scheduling a public hearing date at that time to provide the opportunity for the community to provide input. If a public hearing is scheduled, Anmore will provide notice of the public hearing date to you.
